Annual and intermediate plans for addiction services:

Nassau County Department of Human Services, Office of Mental Health, Chemical Dependency and Developmental Disabilities Services was awarded a multi-million-dollar opioid settlement. A Request for Expression of Interest (RFEI) has been proposed to address the opioid epidemic and substance use challenges endured by Nassau County residences. The RFEI is intended to award multiple contracts, over a four-year sustainability period to address areas in Treatment and Recovery, Education, Prevention, and Supports to meet legislature requirements. Expected program implementation targeted for 2023.

Annual and intermediate plans for <u>developmental disability</u> services:

Nasau County, LGU, continues to explore opportunities to help strengthen the collaborative relationship with NYS-Office of People with Developmental Disabilities (NYS-OPWDD). Currently NYS-OPWDD manages and coordinates all services without the inclusion of the LGU in its coordination of services.

Often families outreach to the LGU for guidance and assistance in navigating the system of care for their loved ones, unfortunately, the LGU is limited to the assistance it can provide. As a result, Nassau County has created a care coordination pilot program design to assist providers and families in accessing services through OPWDD. Coordination services includes consultation, advocacy, outreach, education and access to direct services.

Areas of ongoing concern includes addressing the needs of comorbidities within the systems.

Annual and intermediate plans for mental health services:

Nassau County implemented American Rescue Plan Recovery Funds to be accessed by Community Based Organizations to assist with the impact of the COVID Pandemic.

Nassau County was granted by NYS OMH an expansion to the Forensic ACT Services by 20 slots and added a new Youth Act Team. The Youth Act teams serves ages 10 to 21.

NYS OMH awarded one of Nassau County's CBOs, funds to establish a Crisis Stabilization Center. The Crisis Stabilization Center includes collaborative efforts with other community-based organizations in developing a centralized system.

Nassau County new police reform initiative incorporates Mobile Crisis Team to assist in deescalating calls relating to mental health crisis. The Office has developed a partnership with the 911 Call Center and several police precincts.
