Goal 1: Oneida County will work towards reducing costs associated with Criminal Procedure Law (CPL) 730. Goals for this initiative include diverting individuals from the criminal justice system (if appropriate), reducing restorative periods if treatment goals have been met, and linking individuals to appropriate treatment, services, and supports **Goal 2:** Oneida County will work to enhance Mental Hygiene Law in our community by promoting education, encouraging compliance, and ensuring proper execution of such laws.

Goal 3: Oneida County will advocate for appropriate resources (such as crisis services, housing, and treatment) for those in our community. Oneida County will work to bridge the gap between service areas to provide better resources for those who are dually diagnosed. Advocacy for such resources will be discussed with New York State agencies.

Annual and intermediate plans for <u>addiction</u> services:

Oneida County is actively working with all agencies in the community to allow for a seamless transition of care. Additionally, Oneida County will collaborate with agencies to aid in the implementation of MAT and mobile MAT units to expand outreach to rural and at need areas within the county. Oneida County will partner with community partners to create a stigma campaign, which will foster a judgment free care system, and in turn, make treatment a normalized process.

Annual and intermediate plans for developmental disability services:

Oneida County will continue to advocate for more respite and crisis services to be offered for the I/DD community. Oneida County will work with newly formed agencies to expand and educate the community about services to help alleviate emergency room visits.

Annual and intermediate plans for mental health services:

Oneida County will collaborate with agencies in the county to increase their current capacity for patients and create more opportunities for mental health assessments. Oneida County will aid stakeholders in reducing the risk of chronic diseases related to mental health and substance abuse. Oneida County will strengthen and increase the quality and range of treatment, rehabilitation, and supports for community members.
