Please describe any unmet mental health service needs that have improved:

- Adult Mental Health Services:
 - Adult Mental Health Supportive Housing has improved. The re-designation of the Catholic Charities Forensic Phase 2 supportive housing beds to Forensic Phase 1 was a step forward in ensuring that the beds are being utilized. Three out of four of those beds were re-designated. This change has increased utilization of those beds (which previously went empty) and created housing for our forensic population who are typically very difficult to house and end up in the shelter. The DePaul ESHI Project located in Rome was finished, adding 40 supportive apartments for individuals and families with mental illness. The program has been accepting referrals through ASPOA, and is prioritizing housing for those experiencing homelessness. The Utica version of this program at the starting line is still under construction, but once finished will add 30 additional supportive apartments for MH.
 - Crisis Response Services have Improved. Neighborhood Center's Mobile Crisis Assessment Team (MCAT) has added a Bridge Script Program. The program has access to a psychiatric NP that can provide a bridge script if the client qualifies for short term medication intervention. The clients are screened by a member of the team in addition to the program director and Psychaitric NP. The goal of this program is to reduce the number of emergency room visits for the purposes of obtaining a bridge script.
 - CNY Services Forensic Evaluation Unit has served 529 individuals in 2019 with only a 2% recidivism rate.
- Children's Behavioral Health Services:?
 - The Children and Family Treatment Support Services program has incressed the number of children receiving home and community based children's behavioral health services drastically in the past year. There are approximately 260 children in Oneida County receiving services through CFTSS.
 - The Children's ACT program through ICAN has been extended, and will be used as a model to expand across the state. The program currently services 87 children in Oneida County.
 - School Based clinic programs have expanded in Oneida County. There are now school based clinics in 15 of Oneida County's schools.

• School Based linkage and referral services have improved with the expansion of the Rome Community School Program, now Connected Community Schools. Over the last year the program has made 741 referrals for children and their families to needed programs and services in the community.

Please describe any unmet mental health service needs that have stayed the same:

- Transportation services continues to be an area of concern, as it relates to poor attendance at clinic appointments.
- There is no option for a community residence for youth/adolescents within the county.
- The adult slots in community residences within the county are often full, so referrals are usually waitlisted.

Please describe any unmet mental health service needs that have worsened:

- The lack of psychiatric prescribers for outpatient mental health services has worsened in the last year. This is based on the appointment wait time being prolonged and in some cases the inability of clinics to accept new patients.
- Recruitment and retention for mental health agencies continues to be an ongoing local concern. High turnover rates and the inability to fill positions quickly with qualified people continues to impact consumers of mental health services that either have to be waitlisted due to staffing problems, or will not have consistency with service providers.
- The lack of enough non-Medicaid home based behavioral health services for children is an area of growing concern. Despite the growth in these services for the Medicaid population, there has not been an improvement in these services for the non-medication youth. There is also a need for additional service providers for these services, as the growth in providers has not kept up with the rapid rate of expansion of services.
- Inpatient psychiatric services continue to be an area of concern. There has been a need to reduce capacity in the inpatient psychiatric units in order to accommodate patient needs due to the number of highly assaultive patients that are being admitted.
- A lack of planned and crisis respite services continues to be an area of need. There has been a delay in addressing this area of need due to the COVID 19 pandemic, as deadlines for projects have been pushed into the future. There also continues to be a staffing problem for service providers that can provide hourly respite.

b) Indicate how the level of unmet **substance use disorder (SUD) needs**, overall, has changed over the past year: Improved O Stayed the Same O Worsened

Please describe any unmet **SUD** service needs that have **improved**:

Oneida County Department of Mental Health works in collaboration with Oneida County Public Health and the local emergency rooms to address individuals who arrive at the emergency room with OUD. Oneida County has developed "Oneida Matters" which is a replicate of Buffalo Matters. The local SUD clinics have agreed to participate and work with the individuals on expeditious appointments for them to receive MAT. A number of emergency room doctors have received the Buprenorphine waiver training and will prescribe enough Buprenorphine to the individual to last until their appointment with the outpatient SUD clinic.

Beacon Center has developed same day Buprenorphine appointments for scheduled and walk in individuals. The two other SUD clinics have developed a fast track for individuals to receive MAT, usually within two to three days.

Prevention services through Center for Family Life and Recovery (CFLR) have expanded to reach more individuals throughout the county. CFLR increased their community coalition events and people served by 12%. CFLR'S PREVENTION SERVICES were recognized by OASAS as one of the most comprehensive and creative programs of implementing prevention services in the state. CFLR increased prevention services with the underserved population as well as their Concealing Secrets Teen Mobile Bedroom Kit Part 1 & Part 2 had a 50% increase in events and 44% increase in attendance.

Peer services have increased and improved, OD Mapping has been keeping track of the reported 911 overdoses; peers are dispatched to connect and offer services to assist in engaging individuals to support and treatment. For 2019 73 individuals who overdosed were connected to services.

Oneida County has had increased community based Narcan trainings.

Agencies are getting better with embracing Harm Reduction, though at the same time, it is still a challenging concept for many and how it is navigated, and more training is needed.

Please describe any unmet SUD service needs that have stayed the same:

Heroin and Opioid use has remained a significant issue in Oneida County, as in most counties the Heroin and Opioid use has strained the existing resources in the county.

Areas that continue to be strengths/challenges are transportation, housing, crisis services, workforce recruitment/retention, job opportunities, and prevention, recovery and support services. As well as the problem gambling and Adverse Childhood Experiences.

Another area that has stayed the same is the coordination/integration with the other systems. The OASAS, OMH, OPWDD systems have operated vertically for years resulting in a less responsive ability to address complex multi-disciplinary cases. For those individuals with co-occurring MH/SUD/DD or a combination of two or all three diagnoses services are not easily available for them to meet their needs.

Mental Health Clinics are not a direct service provider of SUD services therefore capacity issues related to Mental Health Clinics to properly access for SUD are deficient for those with co-occurring diagnoses.

There continues to be a shortage of psychiatry available (complex issues) within the SUD system, a continued high-level unmet SUD workforce/retention issue.

Oneida County does not have any SUD treatment (counseling, groups) in the county jail.

In 2019, Oneida County lost its last male supportive living facility.

Oneida County SUD providers will treat adolescent individually however none of the programs offer groups or a specific adolescent track.

Housing, workforce recruitment/retention continue to be the highest needs along with community habilitation services and children's services have been identified as high-unmet needs that have not improved. Residential services, crisis services and respite services continue to be other unmet needs that are highly sought after.

- voluntary agencies have a lack of staff to provide habilitation services and hourly respite
- Lack of overnight respite services

Oneida County has a high need for housing for individuals with mental health, substance use disorders, developmental disabilities, transition age youth who are mental health consumers, and children with a serious emotional disturbance.

Oneida County does not have access to any housing programs within the county for children/youth with SED. Oneida County youth in need of these services are referred out of county in areas unfamiliar to the youth and families of these youth, making it difficult family visitation and participation.

The adult slots in community residences within the county are often full, so referrals are usually waitlisted. There is a particular need for programs that serve clients with multiple diagnoses MH/DD/SUD.

There are no crisis beds within Oneida County for adults or youth.

The Long Term Supported Housing beds are not utilized to their maximum capacity, typically under 70%, due to the strict eligibility criteria. While there are community members in need of this level of care, they often fall short of the eligibility criteria due to being in a state hospital setting for less than 6 months.

There is a high need for respite and transitional housing for children with developmental disabilities.

According to the needs assessment completed by service providers, transportation is the reason for about 40% of
missed appointments. Transportation is particularly a problem in the rural areas that do not offer public transportation.
While there is a rural transit program, the lines and stops are very limited. The program is not well known to
consumers, and underutilized. Medicaid cab is utilized, but has been found to be unreliable at times.

Catholic Charities invested in an agency vehicle to assist residents with transportation.

The Department of Mental Health has met with Oneida County Planning Department/Rural Transit to discuss barriers and possible soulutions for the the transportation issues of our County. Information was obtained about the Rural Transportation System and it was shared with service providers at the ASPOA meeting.

- Oneida County has a lack of crisis intervention services that can address individuals with SUD and youth specific crisis intervention training. Oneida County needs more post crisis planning. More training needs to be done with all different providers, at all levels and professions in Oneida County.
- According to Psyckes data, Oneida County's rate of high utilization of inpatient and ER services is 31.52% compared to a statewide rate of 23.79%, indicating a need for crisis stabilization services.
- Crisis stabilization services for individuals with SUD remains a need as well.
- The Oneida County treatment community continues to have several individuals who have complicated high needs and are high utilizer of emergency/law enforcement/hospital/human services resources.

• There is a significant need for crisis respite housing services and crisis care management for OPWDD enrolled individuals. This is especially true for individuals who are chronically homeless and/or poorly engaged with their care manager or other service providers that could help facilitate stability. The amount of resources it takes to intervene with these individuals is significant and there are growing safety concerns.

Neighborhood Center's Mobile Crisis Assessment Team has added a bridge script program to their servcies to reduce the reliance on the Emergency Departments for the purpose of filling a script while waiting for a clinic appointment.

Through CFTSS children's crisis servcies is now billable through Medicaid.

• Workforce Recruitment and Retention is an area that Oneida County faces some of their biggest challenges. This past year there has been multiple losses of qualified psychiatrists in area clinics, which has resulted in a slower access to psychiatric services. In the needs assessment completed by area mental health providers 96% report a need for additional mental health prescribers in Oneida County, while 68% report a need for additional mental health counselors. There is also a recognized need for other mental health service providers and direct support staff. Children's SPOA has reported on multiple occasions a trend of children waiting for services due to lack of a qualified provider to assign.

- •
- Workforce recruitment and retention remains one of the hightest-level of unmet needs within Oneida County across the mental hygiene service system. There remains a need for more providers across multiple disciplines, however the demand for medical professional is particularly high. The challenges in this area have begun to overwhelm and cause issues in other areas of service; for example lack of psychiatry causes clinics to have limited capacity.
- There is also an increasing need for providers who are able and willing to work with some of the more challenging population of individuals who are presenting with co-occurring, multi system, high need, high risk issues such as individuals with multiple acute medical/MH/SUD/DD diagnoses, forensic histories, and sex offenders. However, low salaries, both in general and in comparison, to the increased difficulty of the work, leads to limitations in recruitment, high turnover and limited workforce.
- Another recognized need around work force recruitment/retention is for existing providers to receive training to enhance their skills and abilities to work with the growing population of high need individuals; for example, training around how to work with an individual with multi-system diagnoses. It is noted, however that staff development and training also require resources, funds and time away from service provision so these efforts can be difficult to achieve at times.

Our community has seen a decline in staff and providers. It is difficult to keep staff once hired. It is difficult to allow staff to attend trainings, becasue there is often not enough staff to cover the office. Not enough qualified individuals are applying,

and are instead leaving the community for better opportunities. The lack of skilled staff has an advese impact on the quality of service delivery.

Due to COVID 19 there was a barrier to being able to follow through on goals related to recruitment and retention. Specifically there were planned job fairs for the MH/SUD/DD agencies, but those plans were delayed.

- Stigma is a problem for many employers who hire people with mental health, substance use disorders, or developmental disabilities. These employers are do not understand the need for these individuals to attend treatment in a manner that is as sensative as an employee needing medical treatment. This can create tension at the workplace and increase chances for employees with these need to miss treatment that is necessary to keep them healthy and productive. There is also a concern of people getting "trapped" in the system. This occurs often when agencies are discouraging clients to become fully financially independent in order to keep them eligible for services. Some agencies rely on funding based on the client meeting eligibility for public assistance, and there is no good method of transitioning them from services to independence hence fostering a cycle of dependence on the system.

SUD: Prevention services in Oneida County are provided by Center for Family Life and Recovery (CFLR) the only OASAS license and funded prevention provider in Oneida County. CFLR provides prevention throughout Oneida County; they provide services to some of the school districts as well as work with community agencies throughout. CFLR uses evidence based programing, provides wraparound prevention services for children/families, and collaborates with other agencies; stakeholders and law enforcement to get provide the much-needed information regarding prevention to the community.

In the 2018 – 2019 school year CFLR participated in 59 community coalitions' events reaching 2,176 people, they attended two town hall meetings to address underage drinking serving 36 individuals.

CFLR participates in social marketing campaigns regarding multiple topics to raise awareness of opioid abuse; they were able to reach 18,420 people. CFLR also sponsors 10 med-return units; billboards advertising were used to educate the community on a safe way to dispose of their unused or expired OTC and prescription medications. As of April 20019 Oneida County has collected 15,136 pounds of unused medications keeping them out of the hands of children and others.

CFLR has developed "Concealing Secrets" Part 1 and 2: a mobile bedroom kit to educate parents, staff and the community on what drug trends, indicators, and where/how it is being concealed by a very interactive and innovative way. CFLR has held 17 events and reached 1,483 people.

CFLR has also held and participated in many other events such as health expos/health fairs, substance/alcohol awareness and education on college campus, presentations to seniors and lunch and learns for prevention education with clergy from faith-based communities in Oneida County reaching more then 4,500 individuals.

The LGU has recognized a need to work across systems to increase early identification of problems that may lead to an impact on overall wellness. The Children's SPOA Coordinator has registered for the upcoming System of Care Training in hopes of partnering with local agency staff in developing a system of care approach in Oneida County.

Suicide Prevention: The Oneida County Suicide Prevention Coalition is facilitated by CFLR. Reducing the stigma and training staff to address the issue of suicide in the Oneida County community remains a priority within Oneida County. The coalition would like to continue to educate the community on suicide prevention and awareness with initiatives and trainings such as SAFE TALK, ASSIST, CONNECT and "Out of the Darkness" events. The suicide coalition would like to bring awareness, educate, prevent and support individuals/families affected by suicide/attempts, CFLR has developed #You Matter.

SUD Peer Services: There continues to be a need for 24/7 peer services in Oneida County. Oneida County LGU continues to build relationships with the agencies who have peers to offer support. The Dept. of Mental Health has develop a Peer group that involves peers from SUD, MH and family support peers. We have heard from the agencies that the peers have a dual role when working with individuals. They will find that more support are needed that are not their specialty. This group brings them together for networking as well to help the individuals they encounter with the best possible resources. The group hopes to bring training from all three areas to expand the knowledge of the peers in different areas so they can provide the best appropriate supports needed.

Oneida County has a large recovery population however; Oneida County does not have a Recovery Center for individuals in recovery and their families. Oneida County has a Friends of Recovery Support Group who actively works with the Recovery Work Team under the Oneida County Opioid Steering Committee. The two groups are working diligently to bring a muchneeded Recovery Center to Oneida County.

Oneida County also lacks a Club House for those under the age of 18, a club house will provide a place for young people in recovery or at risk for addiction to develop social skills that promote long-term health, wellness, and a drug-free lifestyle.

Family Support for SUD: Oneida County has a Family Support Navigator (FSN) services through CFLR. As we know substance use does not just affect the individual, therefore Family Support Navigation services were developed to help the loved ones of those struggling with substance use disorders. Family Support Navigation Services are a significant addition to Oneida County services putting a strong focus on meeting the needs of family members and not just the person struggling with the substance use. Some of the classes and trainings that are offered to families and loved ones are Community Reinforcement and Family Training (CRAFT), Grandparents Raising Grandchildren, Mindful Communications and Boundary Setting, The Science of Addiction, Rational Emotive Behavioral Therapy (REBT) and Recovery Basics for Families. These services have shown to be very fruitful in the recovery process for the entire families' journey.

Oneida County has several support options for consumers of mental health services. MVPC offers the Mobile Intertion Team, as well as the Corner. Neighborhood Center offers Adult Recovery Services in the Utica and Rome area offering full day opportunities for support/recreation. Peer services are integrated into the Mobile Crisis Assessment Team's Crisis Case Management Program, and Youth/Family Peer Advocatacy are available through ICAN.

There is a need for additional behavioral Health Support Services for Youth/Children without Medicaid. Although there are an increase in these services for children with Medicaid, there are still barriers for ensuring children/youth with Medicaid get supportive services. The budget for this program is typically exhausted quickly and there is a lack of providers for these services, especially in the rural areas.

Oneida County has been using OD MAPPING for 1 ½ years to date Oneida County has tracked all overdoses called in to 911. For 2019 Oneida County had recorded 385 overdoses and 40 fatalities. The Oneida County Overdose Response team works with agencies that have peers so that the peers can reach out to individuals who have overdosed to see if they would like peer support to engage in SUD services. For the year 2019 the peers were able to 73 of the 385 to SUD services.

Oneida County has four outpatient SUD providers who all offer MAT; two of the providers have OTP clinics.

The continued training of professional staff across all areas as well as community members of NARCAN has demonstrated the lifesaving importance. Oneida County LGU continues to support and encourage training and use of NARCAN by all.

Oneida County LGU continues to work with the three Article 31 OMH clinics in regards to guidelines released by NYS OMH to have appropriate screening, identification and management of OUD needs.

Oneida County Dept. of Mental Health continues to collaborate with Oneida County Dept. of Public Health on several initiatives related to addressing the opiate/heroin epidemic.

ACE study made us aware of the importance of learning how adverse childhood expierences lead to trauma and toxic stress.
