- **1.** Call to Order R. York called the meeting to order.
- **2. Roll Call/ Introductions (Name, stakeholder group, agency/organization, title) –** each board member introduced themselves. *See attached attendance*.
- **3.** Welcome Co-Chair and Key Partners R. York formally welcomed Beth Lawyer as co-chair and welcomed our Key Partners. R. York also formally welcome Richelle Gregory, the new DCS in Clinton County. Noting nothing formally needed by the board to seat Richelle on the board.
- 4. **Announcements** R. York discussed the announcement of Pete Griffiths beginning 3/20 as new North Country RPC Coordinator for both the Tug Hill and North Country regions. R. York also directed the board to the adult HCBS update related to elimination of the full CMH assessment. *See attached update*.
- 5. **Approval of January 19**<sup>th</sup> **Meeting Minutes (Motion needed)** R. York asked for a motion to approve the 1/19 minutes including stakeholder minutes. Motion: Mike Lawler; Second: Anne Griffin no discussion (all in favor and motion carried).
- 6. Open Board Seats (2 Key Partners, 2 Youth Advocates) R. York reminded the board we have 2 seats currently opened for key partners and 2 seats currently opened for youth advocates. R. York shared the definition of Key Partner and Youth Advocate to remind the board what we are looking for. Announcement that previously appointed Key Partners, Alan Hipps and John O'Neill are retiring and unable to serve. Comment/suggestion from Barry Brogan for nominations for Office for the Aging.
- 7. Confer on Key Partners Appointments Review Nominations (Motion needed) R. York asked for a motion to appoint Sue Ann Caron, Essex County DSS, as a Key Partner. Motion: JoAnne Caswell; Second: Steve Miccio no discussion. All in favor, none opposed. Motion carried. See attached Key Partner Nomination.

- 8. NEW ITEM: Confer on Youth Advocate Nomination Review Nomination (Motion needed) PYF stakeholder group will be the only voting party. R. York asked for a motion from PYF group to appoint Brennan Williams to a Youth Advocate seat. Motion: Steve Miccio; Second: Anne Griffin. All PYF in favor, none opposed. Motion carried. See attached Youth Advocate Nomination.
- 9. Upcoming milestones and deliverables RPC Lens R. York reviewed the RPC Vision slides
  - **a. Regional Issues Survey** AH reviewed regional issues survey. Survey will be distributed 3/17 and due back 3/24. Results will inform creation of workgroups.
- 10. Stakeholder/Committee Report R. York asked if any stakeholder groups would like to report out since our last meeting on 1/19. Update from CBOs Bob Ross related to unique rural challenges, within each issue; other regions may experience this and may not be unique to the North Country. He suggested we compare notes on this issue with southern tier and western NY counties, as we all share the same challenges serving rural population. In preparation for the Co-Chairs meeting, it would be great if we can identify the rural issues ahead of time versus waiting for waivers.

#### **Adult Home and Community Based Services Update**

Today (3/7/17), in joint announcement from OMH and DOH, the state announced the following changes re: to the Health Home program and HCBS services access.

### The Full CMH Assessment is being eliminated effective immediately.

- The Brief CMH Assessment will be sufficient for purposes of HARP and HCBS Services.
- CMAs will bill for the Brief Assessment.
- Guidance will be forthcoming.

#### CMAs will be able to bill e-MedNY directly for Assessments

• This is an interim structure to address the issues of connecting the Plans files and the Billing Support File. Set to go into effect on April 1<sup>st</sup>, 2017.

### Accessing HCBS Services for Non-Health Home HARP enrollees.

- The Conference and the RPC's have been consistently raising with the state the issue that HARP enrollees have choice and if an individual chooses <u>not to enroll</u> in a Health Home, that choice should not prevent access to HCBS they are entitled to receive.
- The state announced that they are developing guidance for how HARP enrollees, who do not want to enroll in a HH, can access HCBS services.
- Guidance will be forthcoming

#### **Alternative Assessors.**

• The state indicated that they are "exploring" other alternatives for assessors to allow others who know and work closely with individuals to assess them for HCBS services.
