2024 First Quarterly Report

1. Goal: Transportation is available in support of behavioral health evaluation and treatment for those in need.

1. Objective: Community Behavioral Health providers are surveyed regarding missed or delayed clinical appointments due to transportation issues. Survey data is analyzed and discussed with providers and a panel of consumers.

Due 4/1/24

Partially completed. The preliminary survey with outpatient providers has been completed. Providers do identify missed appointments; late appointments due to transportation difficulties are a problem. Note the lack of specific data, which requires programs to provide specific data and initiate a specific report for this data element if one does not exist. This will be discussed at the 5/3/2024 Behavioral Health Outpatient workgroup.

2. Objective: Yates Behavioral Health agency transportation assets, including vehicles, staff, and transportation-related funding, are inventoried to support patient transportation. The inventory is shared with Behavioral Health Providers.

Due: 6/1/24

Patient transportation assets in support of clinic appointments do not exist currently for the John D. Kelly Outpatient Clinic (JDK) or Finger Lakes Community Health (FLCH). Finger Lakes Area Counseling and Recovery Agency (FLACRA) has had a grant implemented through the Center of Treatment Innovation (COTI) substance use crisis outreach program. That funding provided funding for transportation upon referral across several counties, focused on the substance use treatment population. Under the Healing Communities Study a transportation project was initiated and focused on individuals in outpatient substance use treatment. That focus was based on concerns related to missed appointments and treatment terminations. Preliminary data on that project was positive. Further analysis of data and the effect on drop out or termination rates related to transportation issues needs to be done.

A request was made with FLACRA and Mozaic to collaborate and integrate their services for the mentally ill and with the Yates County Work Force under the Department of Social Services.

A meeting was held with representatives of all three parties to push coordination, cooperation, and regular communication. In addition, collaboration will increase community awareness of work-related options for the mentally ill and the benefit potential for recovery and continued stabilization within the community.

2. Objective: Supportive employment opportunities are identified, and a baseline is created for the Behavioral Health and DD/ID populations in Yates County. The Information is Shared.

Opportunities have been identified, and an effort to develop a baseline is underway.
