2026 Update to 2024-2027 Goals and Objectives Suffolk County Community Mental Hygiene Services

Goal 1

Goal 1, 2026 Status Update: Ongoing

Goal 1, 2026 Status Update Description: The LHD is engaged in ongoing efforts to ameliorate workforce concerns in Suffolk County. The LHD has engaged regional workgroups, initiated new contracts, and promoted local workforce development programs.

Goal 1 Objective 1, 2026 Status Update: N/A

Goal 1 Objective 1, 2026 Status Update Description: This objective is being pursued through the actions of the Suffolk County Workforce Workgroup and local agencies contracted with Suffolk County.

The Suffolk County Workforce Workgroup has kept members informed of professional training (such as crisis services) for staff in the community, team building programs, peer workforce, and professional development. The Workgroup hosted a presentation at 6/12/2025 meeting from the Workforce Development Institute (WDI) to discuss their Interactive Grants Program; a statewide pre-apprentice program and childcare scholarship program. During this same meeting, the Workgroup also hosted a presentation about the 1199SEIU Training and Employment Career Pathways Training Program, which is being provided through the 1115 NY Health Equity Reform Waiver.

The Intellectual & Developmental Disabilities Subcommittee of the Mental Hygiene Services Advisory Board launched the statewide More than Work campaign to recruit Direct Support Professionals. The campaign goals are to educate the public about the importance and fulfilling nature of direct support work and to connect potential job candidates to opportunities supporting New Yorkers with developmental disabilities across the state.

Agencies contracted through the County also contributed to advancement of this objective.

- Association for Mental Health and Wellness (AMHAW)
 - o AMHAW holds professional seminars and trainings several times each year to educate professionals working with children and adolescents who receive mental health services. These seminars better ensure quality services for children and adolescents living with mental illness by helping to keep professionals up-to-date on current research and strategies for intervention.
 - o Provided continuing education through its Center for Peer Excellence by offering ongoing training and skill-building workshops for peers.
 - o Provided support to peers through their Support for Peer Workers Group.
- Long Island Gay and Lesbian Youth (LIGALY): Provided cultural competency training to not for profits, colleges, school districts, the private sector, especially as it pertains to the LGBTQIA+ community.
- Long Island PREP: Through their Suffolk County Opioid Settlement Fund program, LI PREP provides no-cost Continuing Teacher and Leader Education (CTLE) credits through an array of accredited courses and workshops to address substance use prevention and mental health awareness for Suffolk County educators to close knowledge gaps and equip educators with tools and insights into substance use and mental health to foster healthier, safer environments for Suffolk County youth and enhance the behavioral health of both adults and youth.
- Outreach Development Corp:
 - o Through their Suffolk County Opioid Settlement Fund award, Outreach provides scholarships for Credentialed Alcoholism and Substance Abuse (CASAC) counselor training to fill an urgent need in the Suffolk County Workforce. The Suffolk County Workforce Development Scholarships (SCWDS) allows recipients to enroll in CASAC training provided by the Contractor's Outreach Training Institute (OTI). Scholarships cover tuition costs related to facilitating the program, supervision, internships, and career development support for each participant.
 - o Due to programmatic successes, Outreach's contract for this program was extended to provide more CASAC scholarships.
- The Gino Macchio Foundation (GMF): Through their Suffolk County Opioid Settlement Fund award, GMF provides scholarships to individuals officially in recovery. Funds can be used to pay initial employment salaries to an employer of a scholarshiped individual, to the individual for employment related expenses, and to overcome barriers such as transportation, education, housing, personal needs, etc. GMF also contracts with a Job Procurement Coach who supports

paid internships opportunities for scholarship recipients by ensuring they are appropriately monitored and guided throughout worksite placements.

- NYSTART/CSIDD: The NYSTART/CSIDD R5 team is providing clinical training and continuing education to education professionals working with individuals with IDD and MH diagnoses.

Goal 1 Objective 2, 2026 Status Update: Ongoing

Goal 1 Objective 2, 2026 Status Update Description: The Suffolk County Workforce Workgroup has been a platform to encourage local behavioral health agencies to become active in regional career events to advance the field.

- Job fairs organized by the Health and Welfare Council of Long Island and Suffolk County Health Care Job fair were promoted by the Workgroup, with co-chairs prompting participation from member behavioral health agencies.
- The Workgroup brought awareness to Suffolk County NY Forward, a platform sponsored by the Suffolk County Department of Labor (SCDOL), where agencies can post open positions.

- The Workgroup also spotlighted how agencies can collaborate with SCDOL on their mini hiring events, which are hosted across community resource centers.

- Agencies were also encouraged to participate in the Summer Youth Employment Program sponsored by SCDOL.

- The Workgroup also invited a host of presenters from local entities to inform members about present Workforce initiatives in the County. Notably, the Long Island Health Collaborative was featured at the 5/20/25 meeting to present on their newly developed Workplace Development Guide, which explores a wide breadth of career paths in the behavioral health field. The County is exploring avenues by which to promote this material to agencies and community members alike.

Agencies contracted with the County are utilizing funding to provide opportunities for workforce training. The Association for Mental Health and Wellness (AMHAW) provides a Careers in Recovery and Wellness Training program. This is a 10-week classroom experience training for people interested in volunteering or working in the recovery and wellness field as a peer specialist.

At the State level, there was a budget approval for the Targeted Inflationary Increase (TII). 2.6% was provided for certain human service programs, including those serving people with developmental disabilities. This increase is intended to help non-profits address inflation and to support the recruitment and retention of non-executive staff, including Direct Support Professionals (DSPs).

Goal 1 Objective 3, 2026 Status Update: Ongoing

Goal 1 Objective 3, 2026 Status Update Description: To elicit feedback from community agencies, the Suffolk County Monthly Workforce Workgroup has open discussion about recruitment and retention challenges and best practices among agencies that address these concerns.

The LGU has evaluated current workforce practices, and made changes to improve workforce recruitment and retention. The LGU has reviewed programs, and modified/ adjusted accordingly to ease and facilitate hiring. The LGU has also redefined training and education requirements for Children's Coordinated Services (CCSI) Initiative staff, to address challenges with staff recruitment and retention.

Goal 2

Goal 2, 2026 Status Update: Ongoing

Goal 2, 2026 Status Update Description: The LGU has engaged with local and State agencies to identify improve support access through the lifespan, and across the continuum of care.

Goal 2 Objective 1, 2026 Status Update: Not started

Goal 2 Objective 1, 2026 Status Update Description: The LGU has sought input from the New York State Long Term Care Council to better understand opportunities for the LGU to engage in this work. The LGU posed this question to members of the LTTC during an August 2024 meeting, but no one in attendance was able to provide any insight or information about these types of opportunities. The LGU would welcome opportunities to engage with other Counties or the Long Term Care Council to begin work on this objective.

Goal 2 Objective 2, 2026 Status Update: Ongoing

Goal 2 Objective 2, 2026 Status Update Description: The LGU has been actively engaged with local and State agencies to identify these needs across systems of care. In April, 2025 the Suffolk County Office of the Aging gave a presentation at the Suffolk County Mental Health Subcommittee meeting about the services they provide to the aging population in the community, thus informing local provider attendees. While the LGU has joined the quarterly Long Term Care Council meetings to understand how issues related to ageing could impact long term care delivery in Suffolk, the discussions and agendas did not pertain to mental health. As such, the Division of Community Mental Hygiene Services will no longer be attending these quarterly meetings, but will *laissez* and collaborate with the Suffolk County Office of the Ageing as appropriate. Though no longer attending these meetings, the LGU has outreached to the Program Coordinator of Family and Children's Association (FCA) Aging Safely Prevention Coalition to request information on the Coalition's current programs,

strategies and potential areas of collaboration to support these objectives. The LGU attended their coalition meeting on 6/25/25.

Goal 2 Objective 3, 2026 Status Update: Ongoing

Goal 2 Objective 3, 2026 Status Update Description: New awards and program expansion efforts have increased capacity in Suffolk County to expand service opportunities for youth and transitional aged youth.

- Options for Community Living (Options): In 2024, Options received an award from The New York State Office of Mental Health (RFP) for Enhanced Housing for Young Adults with Serious Mental Illness program. This program engages young adults, age 18-25, with supportive services to help them transition from institutional settings, foster care, and homelessness into specialized housing. In December, 2024, supportive housing beds for the program were onboarded. As of June, 2025, 10 supported housing (SH) beds were filled in Suffolk, with 3 more onboarding. There are currently 65 Young Adult (YA) applications for SH and Apartment Treatment Planning (ATP) for Young Adults in Suffolk.
- RiseWell: RiseWell has a regional (Suffolk and Nassau) 48 slot Young Adult ACT team (specific for 18-23 year old). This YA ACT team began accepting referrals 6/2/25.
- Central Nassau (CN) Guidance: CN Guidance expanded their Youth Assertive Community treatment program, through the receipt of a \$450,000 grant to establish Y-ACT team. This is the second Y-ACT team in Suffolk County, which provides an additional 36 opportunities for youth.
- WellLife Network Transitional Age Crisis Residence: In 2025, WellLife received an award from The New York State Office of Mental Health (RFP) for enhanced housing for transition age youth/young adults with serious emotional disturbance. This program will service youth aged 16-23 in an 8-bed community residence.

Goal 3

Goal 3, 2026 Status Update: Ongoing

Goal 3, 2026 Status Update Description: The LGU has been actively engaged in many activities related to the reduction of fatal and non-fatal opioid overdoses in Suffolk County.

Goal 3 Objective 1, 2026 Status Update: Ongoing

Goal 3 Objective 1, 2026 Status Update Description: The Office of the Suffolk County Executive has granted two rounds of Suffolk County Opioid Settlement Fund Awards to local agencies. The opioid settlement fund programs that were chosen (by a Selection Committee) to receive awards in Round 1 began launching in 2023. In total, 38 programs and 4 capital projects were selected to receive funding in Round 1:

- 11 Prevention programs funded
- 3 Harm reduction programs funded
- 20 Treatment programs funded
- 4 Recovery programs funded

Most of these programs were selected to receive funding for a three year period. Data is being collected on a monthly basis from each of these funded programs.

The portal to collect opioid settlement fund applications for an additional round of funding opportunities (Round 2) opened in August 2023. During the application period, 68 applications were received in the portal. From these 68 applications, 32 programs and 1 capital project were selected to receive funding:

- 11 Prevention programs funded
- 2 Harm reduction programs funded
- 16 Treatment programs funded
- 3 Recovery programs funded

The Contract Management Staff at the Division of Community Mental Hygiene Services have worked with each of these agencies to progress through the Suffolk County contracting process, and into implementation.

To increase public awareness of the use of the Suffolk County Opioid Settlement Fund (OSF) to enhance prevention, harm reduction, treatment, and recovery services in the County, the Division of Community Mental Hygiene Services has partnered with the Suffolk County Office of Information Technology (DOIT) to create a public-facing OSF dashboard. This public facing dashboard will:

- Answer questions related with that the Suffolk County OSF is, how agencies applied/ were selected for funding
- Highlight performance performance measures across all OSF programs
- Provide additional resources for OSF information

The content and visualizations for the Dashboard have been developed, and DOIT has created an initial draft. The LGU anticipates that the dashboard will be launched in Summer, 2025.

Goal 3 Objective 2, 2026 Status Update: Ongoing

Goal 3 Objective 2, 2026 Status Update Description: The Division of Community Mental Hygiene services is developing a set of data dashboards to understand who is most at-risk for opioid overdose, and where they are experiencing these overdoses to inform public health responses and to bring resources where they are most needed to support prevention, harm reduction, treatment, and recovery efforts. It is the intent that the opioid overdose dashboard will utilize data from Suffolk County Emergency Medical Services ("EMS") and local police, including information from the High Intensity Drug Trafficking Area (HIDTA) Overdose Detection Mapping Application Program (ODMAP) database, as well as generalized data from the Suffolk County Medical Examiner ("Data"). The dashboard will feature visualizations of fatal and non-fatal opioid overdose information, and display points on a map based on geographic centroids. As protection of individual identities in this regard is key to this agreement, none of the shared data will be presented on the dashboard in a geospatial manner, which could potentially allow personally identifiable information to be compromised. Information will be shared to allow data points to be tracked across multiple demographics.

The Health Department entered into an MOU agreement with Suffolk County IT and the Suffolk County Office of the Medical Examiner to develop the fatal opioid overdose dashboard.

The Division engaged in monthly meetings with the IT and ME team members to develop the dashboard visualizations, and build the data ingestion structure. After several rounds of collaborative edits, a model of the dashboard has been constructed, enabling the Division to interact with the opioid overdose death data from 2008 through present day. Through a series of selection filters (dates, drug, gender, race, age), the Division has the ability to analyze this data over time to determine trends and geographic areas of interest. The fatal opioid overdose dashboard build is nearing completion, with next steps being data quality review. The Division endeavors to develop a public-facing dashboard next, which will include non-fatal opioid overdose information.

The LGU is building capacity to use this enhanced data to plan for future Spike Response and Opioid Fatality Review. Through a sponsorship opportunity offered by the New York Association of County Health Officials (NYSACHO), a staff member from the Division attended the 2024 National Forum on Overdose Fatality Review (OFR). This 2-day, in-person conference was hosted over March 5-6 in Atlanta Georgia, and on applying the OFR framework of multidisciplinary partners using aggregate and case review data to identify and implement recommendations to make impactful community level change. This conference provided information and resources that will be instrumental in planning and launching an OFR in Suffolk County.

Goal 3 Objective 3, 2026 Status Update: Ongoing

Goal 3 Objective 3, 2026 Status Update Description: Through a sponsorship opportunity offered by the New York Association of County Health Officials (NYSACHO), a two staff members from the Division attended the 2024 State Harm Reduction Symposium. This 2-day, in-person conference was hosted over June 4-5 in Albany, NY, and focused on presenting harm reduction initiatives undertaken by County Health departments in New York State, in addition to legal considerations, and NYS Department of Health reporting on drug checking initiatives and aggregate medical examiner/coroner data. This symposium demonstrated practical applications for harm reduction principles for people who use opioids and other drugs. The Division is considering how this information can be applied to Suffolk County.

The Division has created a new page of the Suffolk Stop Addiction website, titled "Alerts". This page is designed to platform and archive potentially lifesaving information for events happening in Suffolk County. The first post on this page (August 15) alerted the community to the detection of carfentanil in a sample of drugs tested by the local Drug User Health Hub, Community Action for Social Justice (CASJ), as part of their OASAS-sponsored community drug checking program. The alert includes information about what carfentanil is, the testing of the sample, and the symptoms experienced by the person whose drugs were tested. The alert then directs the reader to the naloxone resource page, and lists harm reduction safety tips.

Goal 4

Goal 4, 2026 Status Update: Ongoing

Goal 4, 2026 Status Update Description: The LGU has partnered with numerous local agencies to improve access across the care system, and additional funding from State Offices have bolstered these efforts.

Goal 4 Objective 1, 2026 Status Update: Ongoing

Goal 4 Objective 1, 2026 Status Update Description: Community agencies receiving funding through the LGU have expanded access to behavioral health services for justice involved individuals in the County.

- Central Nassau (CN) Guidance: CN Guidance has been approved to start a FACT team in CN Guidance FACT began accepting referrals 4/14/25. This program is prioritizing referrals from Central New York Psychiatric Center (CNYPC).
- Hands Across Long Island (HALI): HALI has been awarded bi-county (Nassau and Suffolk) forensic supportive housing beds, and is now accepting forensic referrals.
- Family Residences & Essential Enterprises (FREE): FREE provides transitional care coordination services focused on the OMH forensic supported housing population. FREE supports individuals in 14 NYS OMH Forensic Supported

Housing beds who are released directly from State prisons or the Pilgrim Psychiatric Center, subsequent to being released from State prisons.

- EAC Network: EAC Network's Transitional Case Management Program provides case management intervention during an inmate's transition from incarceration to the community. EAC provides services both pending and post release to persons being released from Suffolk County correctional facilities with the goal of supporting individuals with SUD, MH or OUD to remove barriers and reduce the risk of relapse leading to incarceration or hospitalization. This program was expanded through a Suffolk County opioid Settlement Fund award.

Goal 4 Objective 2, 2026 Status Update: Ongoing

Goal 4 Objective 2, 2026 Status Update Description: The LHD has engaged regional workgroups, and imitated new contracts with local agencies to reach this objective. The LGU also enhanced direct A-SPOA and C-SPOA services. Local agencies have also been recipients of State-level Requests for Proposals (RFPs), which have furthered this objective.

Workgroups

Partners in Prevention, a workgroup, has developed several public service announcements to inform the public of local behavioral health resources for information and services. The #ClearTheAir campaign was circulated widely on social media, and brought attention to youth cannabis use and related resources. The #BeAHighwayHero campaign was similarly circulated on social media, and brought attention to impaired driving and related resources. Partners in Prevention also hosted the Expanse Conference on 4/29/25 to discuss prevention across the continuum of care.

The Suffolk County Prevention Workgroup developed a specialized bi-lingual presentation called Parents & Families in the Know: Understanding Youth Resources for Developmental Disabilities, Mental Health, and Substance Use Disorders. This presentation helps parents and families to understand resources for youth who are at risk for, or experiencing, developmental disabilities, mental health challenges, and/or using drugs or alcohol. The presentation features contact information for local agencies that can provide parent education and support, and help parents and families with next steps in getting their the support that they need to thrive. The recorded presentation is saved on the Suffolkstopaddiction website for communities to access and view.

The Suffolk County Intellectual and Developmental Disabilities (IDD) Subcommittee canvassed local Suffolk County agencies that provide OPWDD services for participation in the Subcommittee. As a result, 17 agencies expressed interest in participating in this Subcommittee.

The Division collaborated with the Suffolk County Advisory Board on Child Protection (SCABCP) to facilitate the conference Creating Transformational Change for Families Involved with the Child Protective System. This Conference provided cross system information regarding child/family services and access to care. The Conference also included a resource tabling event for youth/family/adult services/resources.

The Town of Brookhaven has given a Certificate of Appreciation to the Boys and Girls Club of Bellport and Suffolk County Multicultural Advisory Committee for the Community Forum hosted on May 30th, discussing mental health and substance use among youth and young adults.

LGU Direct Services

With the goal of increasing access to care, the Division of Community Mental Hygiene Services worked to promote current services and increase access to them, and enhance service delivery.

- Developed a children's mental health services flyer with QR codes for service access information. The LGU has continued to provide training and technical assistance for child service providers, via live office hours, with staff from CSPOA and CBO partnership. These office hours can be accessed through using the QR code on the flyer.
- Initiated the Suffolk County CSPOA Express Application for preventive and intensive services.
- Developed a process to support direct phone conferences with court/judge on youth cases; streamlined and expedited referral process (prioritizing enrollment) for court referrals to Youth Assertive Community Treatment (Y-ACT)/RTF (coordination with OCFS) when youth meets level of care (LOC) requirements
- Enhanced collaboration between CSPOA and Suffolk County Department of Social Services (DSS). This involved increasing communication and case conferencing, providing in-service on functions of CSPOA, and leveraged resources for wraparound support. Additionally, the LGU entered into an MOU with DSS to expand access to crisis residence services to 24 hours a day, 7 days a week.
- In an effort to ensure clients are linked to the most appropriate and beneficial supports and resources for them, ASPOA is working on strengthening its relationship with the health homes in Suffolk County. Northwell Health Home reports wanting to improve the relationship with Suffolk County SPOA, and are working towards Northwell attending SOC meetings, and being sure that Northwell Health Home and providers are aware of SPOA procedures.

- LGU/CSPOA enhanced collaboration with Residential Treatment Facilities (RTF) statewide, including invitation to treatment team meetings/case conferences to facilitate access to community based services
- The LGU developed an email/mail distribution lists to facilitate information/access to care by sharing resources, including Suffolk County Children's services flyer, and Parents and Families in the Know resource flyer (Suffolk County Prevention Workgroup). Using this distribution chain, resource packets were mailed to 70 Suffolk County School District special education/pupil personnel department heads. Presentations were also coordinated in Suffolk school districts regarding services for youth/transition age/families. 23 presentations were delivered to school districts and community based organizations with positive feedback received; presented to 740+ school and CBO staff during 2024.

Community Agencies

Many community agencies have expanded or created new programs through State-level RFPs (or other similar awards), or Suffolk County Opioid Settlements Funds. The LGU has also supported the expansion of programs to meet the behavioral health needs of Suffolk County Residents.

- Central Nassau (CN) Guidance: CN Guidance was awarded a "Critical Time Intervention (CTI) Teams" RFP, issued by the NYS Office of Mental Health
- SOS Support Team: SOS (Safe Options Support) Team has started on Long Island to help link individuals who are street homeless to housing and needed services. The SOS Team has been connected to crisis residence and respite programs to assist homeless individuals in respite upon discharge.
- Youth ACT Teams Governor Hochul announced \$4.5 million awarded to fund services for children and youth living with mental illness. Specifically, this funding will establish 10 Youth Assertive Community Treatment Teams to provide services for children with serious emotional disturbances. Two of these teams will be implemented on Long Island.
 - o Risewell has been awarded a 48-slot Young Adult ACT team regionally (shared between Western Suffolk and Nassau). Suffolk ASPOA/LGU coordinated with Nassau LGU/ASPOA to discuss viable bi-county workflow for referrals to this bi-county ACT team, and are working together to link appropriate transitional age youth to this resource. The team is staffed, and began accepting referrals on 6/2/25.
 - o Central Nassau Guidance has mounted a Youth-ACT program, providing an additional 36 opportunities for Suffolk Youth.
- Options for Community Living (Options): Options was awarded a bi-county (Nassau and Suffolk) Young Adult Supportive housing/Apartment treatment program. Suffolk has worked with LIFO and Nassau LGU to discuss the bi-county needs of this program, and functioning within the SPA to manage the beds. 10 Suffolk beds have been mounted
- Wellbridge: OASAS has amended the authorization for Wellbridge to operate Part 820 Residential Services at 525 Jan way - Auxiliary Building, Calverton effective October 8, 2024. This amendment was based on review and approval of Certification application #2024.060 to increase capacity from 8 to 30.
- South Oaks Hospital: The New York State Office of Mental Health approved South Oaks Partial Hospitalization Program to serve youth (aged 10-17). This allows increased access to care for youth. This change went into effect 11/18/24.
- WellLife Network:
 - o WellLife Network was awarded a grant from the New York State Office of Mental Health for the specialization of their Setauket crisis residence to serve transition age youth (16-23) with significant mental health needs and are involved with or are at risk of Child Welfare involvement.
 - o WellLife Network was awarded by OMH to expand their current Huntington Assertive Community Treatment (ACT) team to a Flexible ACT model, serving up to 100 people. The Flexible ACT team will serve individuals who have serious mental illness (SMI) and who have not been successfully engaged by the traditional mental health treatment system. Flexible ACT builds on the evidence-based model of ACT by enhancing flexibility in the delivery of ACT services, tailored to meet individual's changing needs. The Team will now have 60 ACT slots and 40 ACT Lite slots. The current roster of individuals hosts 60 ACT and 7 ACT lite.
- New Horizon Counseling Center: New Horizon Counseling Center Family Support Navigator (FSN) program provides support to individuals and their families throughout the recovery process and connects them to resources. The FSN program assists individuals and their families to understand the progress of addiction, navigate insurance and treatment systems and find recovery supports. This program was moved to a State contract as of 1/1/25.
- Response of Suffolk County: Through their Suffolk County Opioid Settlement Fund award, Response has expanded their programming, which provides free, confidential, immediately accessible counseling and referral services to individuals experiencing personal crisis.

- Association for Mental Health and Wellness (AMHAW):
 - o Provides information and referrals for persons living with mental illness, their families and service providers through the Mental Health Help Line.
 - o Staffs a Peer Warm Line with peers who have been trained with skills relevant to engaging consumers and providing emotional support, guidance, and problem solving through personal concerns.
 - o Receives and screens calls from Veterans and family members who may be suffering from the impact of Post-traumatic Stress Disorder (PTSD), Traumatic Brain Injury (TBI), and other mental health issues emanating from their military experience and link them to group leaders and appropriate groups.
 - o Operates a Recovery Center that engages people who may be disengaged by or from the formal mental health system programs and who live with risk factors that may result in the need for higher-level settings such as psychiatric/substance use emergency rooms and hospital settings.
- State
- Beginning 2024, CSPOAs are responsible for determining Home and Community Based Service (HCBS) eligibility for youth stepping down from OMH licensed facilities; facilitating access to appropriate level of care (LOC).
- OPWDD introduced a new series of Front Door videos via state website. The videos will guide users through the available services offered.
- The Coalition for the Whole Person is a group of statewide not-for-profit providers advocating for whole person care and to provide equity in services for the OPWDD population. This includes providers statewide, self-advocates and family members. The goal is to develop an all-encompassing plan by educating the public and policymakers and connecting organizations with expertise within the field.
- OPWDD launched a Self-Direction Program Evaluation in January of 2025. They are working with Guide house, to review the policies and processes of the Self-Direction program and gather feedback from stakeholders. This feedback comes from individuals who self-direct their services, their families, advocates, Support Brokers, Fiscal Intermediaries and Care Coordination Organizations.
- A New York State Office of Mental Health RFP has been issued for another Flexible ACT team in the Nassau/Suffolk region.

Goal 4 Objective 3, 2026 Status Update: Ongoing

Goal 4 Objective 3, 2026 Status Update Description: Suffolk County has seen an increase in the number of inpatient and community based beds for residents in need of this service. SOCR (State Operated Community Residences) has worked towards onboarding another 6 SOCR beds to assist with increasing discharges from PPC, as often times the housing can create delays in discharges. An increase in PPC discharges will also increase the admissions, thereby decreasing the waitlist and opening up hospital beds.

Monte Nido at Clementine, opened a Community Residence Eating Disorders Integrated Treatment (CREDIT) program in Northport. The LGU made a preoccupancy visit, and the program is now accepting clients.

SAIL was awarded an RFI by the New York State Office of Mental Health for 45 Apartment Treatment (ATP) beds in Suffolk. Currently, 10 beds have been mounted.

Goal 4, Objective 4: 2026 Status Update: (Added 2026) New

Goal 4, Objective 4, 2026 Status Update Description (Added 2026) Improve access to care for individuals with complex needs through collaborative system transformation.

Goal 5

Goal 5, 2026 Status Update: Ongoing

Goal 5, 2026 Status Update Description: The LGU has developed new relationships with local agencies to increase availability of behavioral health housing. State Office award opportunities have also positively contributed to housing landscape changes.

Goal 5 Objective 1, 2026 Status Update: Ongoing

Goal 5 Objective 1, 2026 Status Update Description: Through the provision of Suffolk County Opioid Settlement Funds, and support of State funding opportunities, the LGU has worked to expand the availability of recovery housing in the County.

Contracted Program Expansion

- Concern Housing: Concern's Support Congregate Licensed Program provides on site rehabilitation to residents of the three state-funded CRSRO programs in Suffolk County by creating service plans that include community integration goals.
- Family Residence & Essential Enterprises (FREE): FREE opened their 6-bed Sunrise Crisis Residence program in Riverhead.

- **Risewell:** It is anticipated that RiseWell's Intensive Crisis Residence and Residential Crisis Support program to go live in June 2025.
- **Association for Mental Health and Wellness (AMHAW):** The LGU hosted an EZ par discussion with AMHAW, anticipating onboarding 4 residential crisis support beds by end of 2025.

Opioid Settlement Fund Programs

- **New Hope Rising (NHR):** Utilizing their Suffolk County opioid Settlement Fund award, NHR provides recovery housing scholarships for those with substance use disorders. NHR provides peer support and vocational assistance to residents and provides continued engagement and support to NHR's recovery housing alumni after they transition out of NHR recovery homes.

State Awarded Programs

- **Hands Across Long Island (HALI):** HALI was awarded 20 regional (shared with Suffolk and Nassau) forensic supportive housing beds. HALI is ready to start receiving forensic referrals from SPA.
- **Central Nassau (CN) Guidance:** CN Guidance was awarded Apartment Treatment (ATP) beds in Suffolk County.
- **Pilgrim Psychiatric Center:** The capacity of the Brentwood SOCR was increased from 24 beds to 26 beds, effective March 11, 2025.
- **Options for Community Living (Options):**
 - o Options was awarded a 20 bed Supported Housing (SH) and 15 bed Apartment Treatment Planning (ATP) housing for young adults. Regionally (shared with Nassau and Suffolk).
 - o Options has been awarded a 50 bed CRSRO (Community Residence, Single Room Occupancy) in Suffolk.
- **SAIL:** SAIL has been awarded 20 ATP beds & 43 Supported Housing (SH) beds in Suffolk. As of 6/10/25, a total of 10 beds have been mounted.
- **3 agencies have been awarded Short Term Transitional Housing (new housing type), regionally (shared with Suffolk and Nassau). 10-14 beds each. 2 anticipated to be physically located in Suffolk, 1 physically located in Nassau. A client can go to any site, regardless of region.**
- **Phoenix House:**
 - o Phoenix House is working to onboard 15 Crisis Residence bed; residential support level of care, 3 locations with 5 beds each.
 - o Phoenix House was awarded a prison re-entry Short Term transitional Residence (STTR). 10-14 beds in 1 unit, for both Suffolk and Nassau residents.
- **WellLife Network:** WellLife was awarded a grant from the New York State Office of Mental health for the specialization of Setauket Community Residence to serve transition age youth (16-23) with significant mental health needs and are involved with or are at risk of Child Welfare involvement.

Goal 5 Objective 2, 2026 Status Update: Ongoing

Goal 5 Objective 2, 2026 Status Update Description: The LGU has engaged with numerous community stakeholders to advance this objective and strengthen the housing opportunities in the County.

The Suffolk County Housing Workgroup meets monthly and has open discussion regarding housing challenges and best practices among agencies that address these concerns. The workgroup schedules presenters each month to discuss various housing topics and issues. The Workgroup has developed and distributed a survey identifying challenges housing providers are faced with in the current behavioral health landscape.

The Crisis Residence/ Crisis Respite quarterly meeting has been engaged in advancing this objective as well. The Workflow for Respite applications has been streamlined, with all applications coming through the SPOA. Similarly, there is an updated process to manage Certified Residential Opportunities (CRO). This will help establish a new application to assist and match individuals with agencies and providers of care management through a platform. The LGU has also facilitated ongoing biweekly residential meetings between CSPOA and the New York State Office of Mental Health to maintain effective communication, expedite service linkage, and establish best practices.

Suffolk County's Housing Coordinator has been presenting at multiple Emergency Rooms/inpatient hospitals to share the new Crisis Residence program, as well as review Respite, in an effort to educate referral sources on which temporary housing option is most suitable for the individual's needs.

Goal 5 Objective 3, 2026 Status Update: Ongoing

Goal 5 Objective 3, 2026 Status Update Description: The LGU has promoted the development of housing opportunities for people with disabilities and special needs.

- Options for Community Living: Options was awarded an RFP by the New York State Office of Mental Health for Housing for Young Adults with Serious Mental Illness program. This RFP focuses on the engagement of engaging young adults, age 18-25, with supportive services to help them transition from institutional settings, foster care, and homelessness into specialized housing.
- WellLife Network: WellLife Network, is developing mixed-use, affordable housing at Medford Gardens; 55 and over community, 67 apartments, 33 are supportive SMI, and 33 are low income, affordable housing, 1 is superintendent live-in.

Pertaining to direct LGU services, 34 Certificates of Need were received from OPWDD and reviewed in 2024. The CON process governs establishment, construction and renovations for residential services for individuals with disabilities.

Goal 6

Goal 6, 2026 Status Update: Ongoing

Goal 6, 2026 Status Update Description: Transportation persists as a significant challenge in Suffolk County.

Goal 6 Objective 1, 2026 Status Update: Ongoing

Goal 6 Objective 1, 2026 Status Update Description: A task group within the Suffolk County Transportation Workgroup is developing a survey to gather measurable data regarding SCAT service use issues. The survey will explore such topics as Medicaid transportation issues, and areas lacking transportation.

Goal 6 Objective 2, 2026 Status Update: Ongoing

Goal 6 Objective 2, 2026 Status Update Description: The Suffolk County Transportation Workgroup meets bi-monthly to facilitate open discussion on the challenges of providing transportation to those in need. Topics of discussion include how to improve current services, and how to reach areas of the County that may not have adequate transportation options.

Goal 6 Objective 3, 2026 Status Update: Ongoing

Goal 6 Objective 3, 2026 Status Update Description: The Suffolk County Opioid Settlement Fund has granted awards to several community agencies to champion transportation challenges in the community.

- WellLife Network: WellLife Network provides and supports transportation to treatment, recovery programs or other services for individuals with an Opioid Use Disorder (OUD) or individuals at risk of an OUD that attend their Addiction Recovery Services (ARS) clinics.
- Gino Macchio Foundation: Through the Put Recovery to Work program, the Gino Macchio Foundation provides individualized aid to scholarship recipients to overcome transportation barriers, which includes reimbursement toward car insurance or mileage as it relates to employment expenses.
- New Hope Rising (NHR): Through the Recovery Housing Program, NHR provides resident transportation through their passenger van to self-help meetings, job interviews, doctor's appointments, mental health appointments, Department of Social Services appointments, court/legal requirements, recovery events and other community resources.
- SCO Family of Services: SCO Family of Services provides transportation for individuals residing in its residential treatment programs, Morning Start I & II in Suffolk County. This Transportation Program arranges transportation for consumers to necessary services when public transportation and or medical transportation is insufficient and/or inappropriate. This includes all necessary supportive services for full and effective integration of the consumer into community life including but not limited to 12-step meetings, therapeutic recreation activities, parenting activities and Suffolk County Department of Social Services.
- Seafeld Services: Seafeld Services provides transportation for clients to necessary services when public transportation and or medical transportation is insufficient and/or inappropriate. The provision of transportation to and from facilities or resources are specified in the client's individual treatment plan as a necessary part of his/her service for substance use disorder. This includes all necessary supportive services for full and effective integration of an individual into community life.
- Dan's Foundation for Recovery: Dan's Foundation for Recovery assists with the varied needs of those with opioid use disorder (OUD) or those at risk of OUD or other co-occurring disorders by providing referrals and financial assistance. They are also equipped to provide transportation to treatment and other non-clinical needs a client may have.
- Phoenix House: Phoenix Houses provides a comprehensive recovery program which includes rehabilitation, clinical services and support services. In support of client recovery, Phoenix Houses has transportation services to community outlets and supportive services.

Other programs have received funding from the New York State Office of Mental Health to facilitate these transportation programs.

- **Risewell:** RiseWell provides a non-medical transportation to individuals who fit the criteria of serious and mental illness who reside in Suffolk County. This program assists people with transportation to places such as the pharmacy, grocery shopping, the movies, a visit with family members and even going to work in an effort to enhance their quality of life by enabling them to actively engage in meaningful day to day activities within their own communities that they may not otherwise be able to access. The purpose of this type of programming is to provide supportive services for full and effective integration of individuals into community life.
