Goal 1, 2026 Status Update: Ongoing

Goal 1, 2026 Status Update Description: We continue to work with Law enforcement and schools to respond to crisis more timely and minimize the need for hospitalization. HBCI is up and running.

Goal 1 Objective 1, 2026 Status Update: Complete

Goal 1 Objective 1, 2026 Status Update Description: HBCI is now operating in Hamilton County. They have been able to present the program to CSB and the SOC. Referrals are beginning to come in.

Goal 1 Objective 2, 2026 Status Update: Ongoing

Goal 1 Objective 2, 2026 Status Update Description: This continues to be a challenge due to even more limited staffing than 1 year ago. However, i small size also allows us flexibility, and we have been able to respond to locations with low enforcement, probation and social services on a number of occasions.
