## 2023 Goals and Plans Form

# St. Lawrence County Community Services

**Goal 1:** Continue to work with volunteer agencies to alleviate workforce shortages. Currently, workforce shortages prohibit expansion of existing agencies and the development of new programs.

Goal 2: Increase affordabale housing, both transitional and supportive,

**Goal 3:** Enhance crisis services via the current provider and/or RFP for a provider of crisis services that meet the guidance and can capitalize on the existing benefit.

**Goal 4 (Optional):** Increase access to afordable transportation for behavioral health, medical, and SDH opportunities.

# Annual and intermediate plans for addiction services:

- -Hire and train one Harm Reduction Specialist, who may also be certified as Peer Recovery Advocate (CRPA), who will spend 100% of their time providing direct service, and harm reduction training to individuals with SUD/OUD, their families, and community members.
- -Distribute Safe Syringe Disposal Units in key county locations.
- -Continued expansion of the newly developed "Rides To Recovery" program which provides transportation to access Social Determinants of Health (places of employment, educational institutions, shopping, entertainment, etc.) and emergency appointments.
- -Increase the evidence-based prevention curriculum "Too Good for drugs; Too Good for Violence" in four additional school districts.
- -Expand "Teen Intervene" prevention program for the County by hiring a 0.5 FTE CRPA to fill the current staff shortage.

# Annual and intermediate plans for developmental disability services:

- -Capitalize on the State initiative to provide an increase in Integrated Business Employment opportunities, which would also require an increase in job-coach staffing.
- -Develop respite services for both adults and children to include planned and crisis placements. Currently the County has no IDD respite care.
- -Develop better support systems for families that have members on the autism spectrum, including early intervention.

- -Increase the workforce of Fiscal Intermediaries to support self-directed care.
- -Develop IRA's for DD individuals stepping down from forensic and psychiatric placements.

# Annual and intermediate plans for mental health services:

- -Identify a provider capable of meeting guidance compliant crisis services to the largest, predominantly rural county in NYS and work towards implementation.
- -Suicide Awareness Coalition will be holding one QPR training each month targeted at veterans, the geriatric population, educational systems, public transportation staff, and the community at large.
- -Current mental health services' waitlists indicate the need for expansion of existing services or newly created Article 31 services, currently prohibited by staff shortages.
- -Continue to develop the CIT program, coupled with a threat assessment management team to improve the collaboration between law enforcement and the behavioral health delivery system.
- Expand the current Mobile Access Program through use of additional iPads.
- -Launch System of Care.
- -Continued development and expansion of the Rides To Recovery program which provides transportation to access Social Determinants of Health (places of employment, educational institutions, shopping, entertainment, etc.) and emergency appointments.
