Many of the goals and objectives from the previous year's plan were integrated into the 2021 Local Service Plan. Analysis of data related to service needs indicate suicide prevention, cross system collaboration, expansion of opioid prevention and treatment services, affordable housing, and transportation are issues of primary focus. The identified goals and objectives of this plan reflect community needs and are consistent with Statewide initiatives. Although the Department of Community Services has recieved State aid and other funding to enhance its service delivery, the demand for services remains strong. Overall, our success in meeting the needs of the community is largely contingent on the adaptability of our providers in response to health care reform and the continuance of State aid funding.

Please describe any unmet mental health service needs that have improved:

Emergency regulatory waivers due to the covid 19 pandemic specific to telehealth and telemedicine have allowed providers to offer treatment and support services to all individuals in need of such services. In some instances providers have reached individuals who under "normal" circumstance would not have received services due to lack of transportation. Crisis respite available through the Elmira Psychiatric Center continues to enhance our hospital diversion efforts specific to adolecsents that are at risk for out of home placement. Similarly, open access intakes offered through the Steuben County Community Mental Health Center (SCCMHC) gives individuals same day or close to same day access to begin mental health treatment. Although it has been slow in its implementation Home and Community Based Services (HCBS) and the provision of Health Home Plus services are becoming more readily available through area agencies.

Please describe any unmet mental health service needs that have stayed the same:

Steuben County continues to feel the negative impact created by the closure of the adult and adolescent psychiatric care units located at St. James Mercy Hospital in Hornell New York. This closure combined with the reduction of inpatient beds at the Elmira Psychiatric Center causes individuals in need of psychiatric hospitalization to travel a significant distance outside the county to hospitals as far as Rochester and Buffalo. Children often times spend days and/or weeks in the emergency department waiting for an inpatient bed. State and local data sources continue to highlight the need for more community based services to enhance hospital diversion efforts. Crisis respite options for children under age 12 continues to be limited.

Please describe any unmet mental health service needs that have worsened:

The closure of the adult psychiatric care unit located at Soldiers & Sailors Memorial Hospital (Yates County, Penn Yan, NY) has further reduced inpatient resources within our Finger Lakes region. Recruitment continues to be a challenge as there is a significant shortage of mental helath professionals availabe to work in our County. In some instances area agencies have had vacant positions for several months if not years. A prime example of this is SCCMHC currently has a total of (10) vacant positions between its mental health, substance abuse, and case management programs- some of which have been vacant for almost two years. Cross system treatment issues specific to inpatient and outpatient community supports continue to be a challenge for individuals who are dually diagnosed especially for those who carry both a psychiatric and developmental disability diagnosis.

Please describe any unmet **SUD** service needs that have **improved**:

CASA-Trinity took on inpatient and outpatient programs previously run by Loyola Recovery Foundation in Hornell NY. Clinic treatment for substance use disorders along with medication assisted treatment (MAT) is available. These services offer "warm hand-offs" to thier detox/inpatient facility or wellness residential programs. Through increased State and local funding access to alcohol and substance abuse treatment has been enhanced for individuals incarcerated at the Steuben County jail. Jail services currently include individual/group counseling and peer supports upon release. Several community forums have been offered to increase education and awarenesss of the risks involved with prescription opioids, heroin, alcohol, and other substances. Community forums have also provided participants with Information on how to access treatment for such issues. Medically assisted inpatient detox services are more readily available through Ira Davenport Hospital's program located in Bath NY. Emergency regulatory waivers due to the covid 19 pandemic specific to telehealth and telemedicine have allowed providers to offer treatment and support services to all persons in need of such services. In some instances providers have reached out to individuals who under "normal" circumstance would not receive services due to lack of transportation. Open access intakes continue to be available to individuals wanting substance abuse treatment through Steuben County Alcohol and Substance Abuse Services (SCASAS). ODMAP is being utilized throughout the County to engage and offer treatment services to individuals who are at risk of opiod overdose.

Please describe any unmet **SUD** service needs that have **stayed the same**:

Although local prevention agencies provide services at many area school districts and youth centers, recent student survey data continues to support the need for increased education and awareness specific to alcohol, marijuanna, and e-cigarettes. Similarly, the data also supports the need for more prevention services related to heroin and other opioid use by teens and young adults between the ages of 15 to 29. Although the Steuben Prevention Coalition did recently recieve federal funding it has received and continues to explore other funding options in an attempt to expand its prevention focus.

Please describe any unmet **SUD** service needs that have **worsened**:

Consistent with the national "epidemic" State and local data indicates that the number of hospital visits and deaths related to heroin and prescription opioids is on the rise in Steuben County. This increase has highlighted the need to expand opioid and other addiction treatment programs within the county. Supportive housing for indivduals in recovery, especially females, continues to be of great need.

Please describe any unmet developmentally disability service needs that have improved:

Although very limited, short term crisis respite located in a contiguous County (Livingston County- Dansville NY 29 miles from Bath NY) is available through the NY START program. Similarly, although services through Care Coordination Organizations (CCO) are available implementation has been slow and public awareness of these services is low.

Please describe any unmet developmentally disability service needs that have stayed the same:

In general, the OPWDD system continues to be difficult to enter as the time it takes from making a referral to completing evaluations for eligibilty and other determinations is an extremely long process taking several months if not longer. Similarly, Steuben County has limited options and long waiting periods specific to residential housing in the community. In addition, Steuben County continues to not have adequate crisis respite and other community support services for individuals with intellectual and developmental disabilities.

Please describe any unmet developmentally disability service needs that have worsened:

Steuben County has seen an increase in the number of developmentally disabled individuals involved in the criminal justice system. Increased staff time and other County resources have been spent managing these cases and mitigating issues with the District Attorney's office, public defenders, and courts. Given the prevelance of individuals that present with complex behavioral and mental health needs more therapeutic in-home community support services are needed.

Many providers did not have and in some cases still don't have the technology they need to provide "remote" offsite services via video conferencing and/or phone services. Similarly consumers of MH, SA, OPWDD services faced the same challenges. Given the geography of Steuben County some individuals do not have access to internet or cell phone service. The provision of Children's services especially younger children has been challenging as it is difficult to get them to participate in online or telephone counseling other than brief periods of time. Not seeing any specific racial/ethnic groups disproportionately impacted by Covid 19 in Steuben County.

Individuals that we have had contact with are reporting increased symptoms of anxiety and depression due to being socially isolated. These same individuals struggle finding ways to cope given the closure of many businesses, gyms, restaurants, etc. Children service needs have increased with the closure of schools. Given the rural nature of our county many students and their families rely on supports they receive through the local school districts. Similar to adults we are seeing an increase in the number of children feeling anxious due to social isolation. Although some individuals are seen face to face in an office setting most providers continue to offer counseling and other support services via video conferencing and/or phone. There has been an increase in crisis outreach services since the onset of Covid 19.

Although some individuals are seen face to face in an office setting most providers continue to offer counseling via video conferencing and phone. Some clients have not followed through with treatment as they have been held less accountable through the legal system/courts. Substance abuse providers have seen a decrease in number of services rendered due to Covid 19 health guidelines reducing the number of people who can attend groups at the same time. In comparison to adults children have been more difficult to engage in telehealth services. There has been an increase in the number of reported drug overdoses since the onset of Covid 19.

Due to Covid 19 Individuals living in community residences have been more isolated due to closures or reduced access to businesses, recreational, or other resources available in the community. Some parents/relatives have removed their son or daughter from community residences due to concerns with Covid 19 and will not return them until there is an effective vaccine available. Many individuals do not have the technology available or struggle with the use to make telehealth services a viable option. Some staff and participant employees of work programs have been furloughed due to Covid 19. Over the past couple months many have been brought back to work but not all due to occupancy restrictions.
