Offer three (3) suicide prevention media/communications campaigns each year through 2027.

Successfully improve youth linkages when returning from hospital/residential (RFT/RTC) placement by through comprehensive discharge planning meetings at least 75% of the time with SPOA. Reduce 90 day return to hospitalization rate at Guthrie Cortland Psychiatric unit by 25% through collaboration planning quarterly meetings focused on high need/risk behavioral health clients in Cortland.
