Goal 1: Title Improve access, increase capacity and use of effective treatment approaches for outpatient Mental Hygiene Services.

Goal 1: Target Completion Date Dec 31, 2025

Goal 1: Description Westchester has experienced a significant demand for outpatient Mental Hygiene Services for children, adolescents and adults. This includes timely access to effective treatment for individuals experiencing behavioral health challenges. Our existing providers experience significant waiting-list and capacity issues due the increased demand for treatment. The population includes both children and adults with co-occurring disorders (which include co-occurring mental health and substance misuse and mental health and developmental/intellection disabilities.

Outpatient clinic capacity is influenced by both lack of parity in behavioral health insurance as well as workforce issues.

Along with timely access, goal is to increase use of effective (evidence-based/best practices) models of treatment.

Goal 1, Objective 1, Description Westchester County will conduct an intensive needs assessment of current outpatient clinic capacity. This will include comprehensive assessment of each current outpatient agency waiting list, use of evidence-based/best practices, utilization rates, insurance/pay mix and ability to expand capacity. This includes treatment services for children, adolescents and adult with mental health, substance misuse, developmental/intellectual disabilities and co-occurring disorders.

Goal 1, Objective 2: Title Westchester promotion of co-occurring evidence-based/best practices approaches

Goal 1, Objective 2, Target Completion Date Jan 01, 2024

Goal 1, Objective 2, Description Westchester formed a Co-Occurring System of Care (COSOC) initiative in 2017. COSOC includes a partnership with major stakeholders including treatment providers with the goal of strengthening co-occurring competent care by addressing regulatory, licensing, workforce, practice approaches and integrated care models. Most recently Westchester was recipient of a \$2.7 SAMHSA co-occurring treatment grant, began an integrated treatment Learning Collaborative and building practice capacity for competent outpatient care.

Goal 2: Description Westchester County has experiences significant challenges in workforce recruitment and retention in all sectors including mental health, substance use and developmental/disabilities service systems.

While the recent 2-year NYS COLA's have been extremely helpful in areas of workforce, there continues to be significant shortages in workforce.

Westchester County DCMH plan is to work with various critical stakeholders including providers, higher education and other partners to strengthen our workforce.

Goal 3: Description Westchester County DCMH will continue to address high demand for housing services for individual with mental health, substance misuse, developmental/intellectual and co-occurring needs.

There continues to be lengthy waiting-list for housing including need for higher levels of support and supportive housing opportunities.

NYS and OMH 2023 Rehabilitative and Tenancy Support Services to increase the accessibility of scattered site supportive housing to individuals with more complex needs by providing the support services necessary to promote stability in the community had a significant impact on service delivery system. Westchester has also benefitted from the continued approval of the Empire State Supported Housing initiative grants for providers and for the new funding in the budget for available housing.

Along with housing needs, there continues to be lack of resources for residential substance use treatment facilities in Westchester County. This has led to unserved residents including no adolescent residential treatment beds in Westchester County.

Westchester County DCMH is very concerned about OPWDD recent decision to exclude LGU's from the Access to Residential Opportunities Committee (AROC). Furthermore, OPWDD no longer provides LGU's with monthly emergency needs housing reports. Without this data and involvement in the housing process, Counties are unable to support the needs of our residents and there is a lack of transparency in planning and resource capacity and needs.

OBJECTIVE UPDATES

Objective #1 Needs Assessment of Current Outpatient services and capacity to expand. County has done needs assessment and there continues to be significant access and capacity issue that has led to waiting lists and continued need. There has been an increase in outpatient school-based Mental Health satellite clinics over past 12 months. Significant gap in co-occurring MH/DD-ID treatment.

Objective #2 Westchester promotion of co-occurring evidence-based/best practices approaches. Westchester's system of care has expanded use of evidence-based practices including co-occurring treatment for adolescents/young adults through funding from Opioid Settlement funds and SAMHSA Grant. Through opioid settlement funds also increase in co-occurring treatment for Menta health/substance use disorder providers. There continues to be significant lack of treatment options for children and adults who experience mental health and developmental disabilities and Autism Spectrum.

OBJECTIVE UPDATES

Objective #1 Westchester County DCMH will continue to address increased housing needs. Adult SPOA continues to manage waiting list and collaborate with providers to maximize housing opportunities. Westchester has 2 agencies, who provide SUD residential options, that are pending opening and receiving funding.

Objective #2 Expand SUD Adolescent/Co-Occurring treatment bed capacity. Westchester has not been successful in developing new programs. Challenge has been identifying site/building and secure funding necessary. We will continue to explore potential funding stream and collaboration between various entities to create and sustain such a model.

Objective #3 Address OPWDD Residential opportunities and shared planning with LGU. Westchester has not been able to obtain data from OPWDD on waiting list, capacity and vacancy rates for residential opportunities for Westchester residents. This has been a major concern as LGU receives constant calls from residents, providers and elected officials on needs, waiting list and status of individuals. The lack of housing, transparency and shared planning has led to use of inappropriate psychiatric hospitalizations, police involvement and family crisis.

2026 Update to 2024-2027 Goals and Objectives Westchester County Community Mental Health Department

Goal 1

Goal 1, 2026 Status Update: Ongoing

Goal 1, 2026 Status Update Description: Improve access, increase capacity and use of effective treatment approaches for outpatient Mental Hygiene Services is an on-going goal.

While there has been progress in increasing capacity and access to effective treatment for outpatient services, there continues to be significant waiting lists and on-going need for services.

The issue of access to effective and timely treatment is often influenced by insurance plans, agency workforce shortages and ability to provide co-occurring competent care.

Westchester County DCMH remains committed to integrated school-based mental health models - including school-based satellite clinics. In 2022-2023 55 SBMHC existed and in school year 2024-2025 increased to 76 SBMHC, at least 3 more anticipated for 2025-2026 school year county-wide.

DCMH and its 0-6 Subcommittee is collaborating with partners to train and expand capacity for Child Parent Psychotherapy (CPP) for children under age 6 and their families. A new clinic is now designated for CPP< and these services are now available to families of children facing foster care placement, through Strong Starts Initiative and through direct referrals from Dept of Social Services.

Westchester County Dept of Community Mental Health is close to opening an Article 31 outpatient clinic for adults. The capacity will be to serve 120 adults.

There continues to be a major service gap in serving both children and adults with both developmental/intellectual disabilities and mental health needs.

Goal 1 Objective 1, 2026 Status Update: Ongoing

Goal 1 Objective 1, 2026 Status Update Description: Needs Assessment of Current Outpatient services and capacity to expand in an ongoing goal. Over the past 3 years Westchester County has done a needs assessment to address access to services and capacity issues. There continues to be significant waiting lists and on-going need for services.

Westchester will continue ongoing needs assessment and monitoring of new services and identified needs. This includes insurance parity and access to timely and effective care and populations of need.

As we explore opportunities to expand access to timely and effective treatment we continue to explore specific community needs/gaps in services, opportunities to explore care in integrated settings as well as promote and support use of evidence-based practices.

Goal 1 Objective 2, 2026 Status Update: Ongoing

Goal 1 Objective 2, 2026 Status Update Description: Westchester County continues to promote, and support, use of co-occurring evidence-based/best practices approaches.

Westchester's System of Care has expanded use of evidence-based practices. Our efforts have included promoting and supporting co-occurring treatment for adolescents/young adults experiencing mental health and substance misuse disorder through funding from Opioid Settlement funds to support co-occurring treatment for both adolescents and adults. In addition, Westchester was awarded a SAMHSA Adolescent TREE Grant which offers evidence-based treatment through Encompass. More recently Westchester received private funding to expand use of Encompass.

There continues to be significant lack of treatment options for children and adults who experience mental health and developmental/intellectual disabilities and Autism Spectrum. There are limited amount of service providers who have the expertise to provide competent care to individual s with DD/ID particularly those individuals on the autism spectrum who have co-occurring mental health and complex behavioral support needs.

CP Unlimited was awarded funding to establish a "step-down" program in Westchester County to help adults living with co-occurring mental illness and intellectual/developmental disabilities safety transition back into their community following care within an inpatient setting. Individuals with co-occurring mental health and IDD often have high use of emergency and inpatient psychiatric care, even when they can be better served in the community.

Goal 2

Goal 2, 2026 Status Update: Ongoing

Goal 2, 2026 Status Update Description: Westchester County has experiences significant challenges in workforce recruitment and retention in all sectors including mental health, substance use and developmental/disabilities service systems.

More recently there has been increased support to address this challenge. NYS loan forgiveness funding, COLA increase and NYS 1115 Career Pathways program and financial support has made a great impact in supporting our students and future workforce.

DCMH in collaboration with cross-systems partners and Westchester County Employment Opportunity Center (EOC), is developing a model that will improve, enhance, and systemize the hiring and retention of peers, essential to County's ability to deliver services across Westchester in the most effective fashion.

Westchester continues its efforts to offer CRPA scholarships for OMH Certified Peers. County is currently funding individual to get their OASAS Peer Supervisory Professional (PSP) Credential.

There is a continued need to recruit, support and expand our workforce.

Goal 2 Objective 1, 2026 Status Update: Ongoing

Goal 2 Objective 1, 2026 Status Update Description: The Westchester County Behavioral Health Workforce Shortage & Pipeline Initiative is a collaborative effort launched in early 2024 to address the critical shortage of qualified behavioral health professionals. Led by a cross-sector partnership of county government, educational institutions, behavioral health providers, hospitals, and nonprofit agencies, the initiative seeks to attract, train, and retain a diverse workforce.

This initiative brings together a cross-sector coalition--high schools, universities, behavioral health providers, hospitals, healthcare systems, county agencies, and other stakeholders--to develop and implement coordinated strategies that:

- Spark early interest in behavioral health careers through school-based outreach and education.
- Facilitate career awareness and exposure through information sessions and professional Networking.
- Establish a direct pathway from higher education to field placements and employment.
- Develop supportive learning environments through shared field supervision standards.
- Promote workforce retention by enhancing onboarding support and peer collaboration.

The initiative is working with Putnam/Northern Westchester BOCES to offer career awareness for High School Students and offer a specialized "New Visions" program, an academically rigorous one year programs for college bound seniors. These programs allow students to earn honors, AP and college credit while working with industry professionals. Many of the New Visions programs are located at sites where students can watch and learn from field practitioners in their work environment. Students who are interested in participating in New Visions programs must have a strong commitment to the selected career area. Westchester is exploring creating a "New Visions" Behavioral Health track for 2026-2027 school year.

The Westchester County Behavioral Health Workforce Shortage & Pipeline Initiative is implementing enhanced university outreach, educational forums and direct field placement and employment track for students.

Goal 2 Objective 2, 2026 Status Update Description: Westchester has seen benefits of efforts such as rate increases, COLA and other incentives such as student tuition forgiveness to slightly improve retention issues. Westchester's System of Care continues to explore opportunities to work across agencies to provide appropriate trauma informed to staff including our System of Care Trauma Committee provides Trauma Informed Supervision sessions for any system or provider.

The Westchester County Behavioral Health Workforce Shortage & Pipeline Initiative is also focused on new staff entering the workforce and providing enhanced support and networking opportunities.

Goal 3 Objective 1, 2026 Status Update: Ongoing

Goal 3 Objective 1, 2026 Status Update Description: Westchester continues to work with OMH and providers to expand housing capacity. This includes receiving funding for 20 Housing First beds that are intended for individual who are homeless, specifically those who are working with the Safe Options Support Team.

Additionally, one provider was just awarded an ESSHI grant for the frail elderly who have SMI. Other agencies are actively working on ESSHI projects that are sited. Barriers include community opposition to new housing projects, high rents, fewer available units, and, in some cases, blatant discrimination. Westchester LGU is working closely with our county WRO's Fair Housing Department to address episodes of discrimination (where an apartment will suddenly be "rented" when the landlord finds out it is an agency seeking tenancy). Many landlords are now requiring credit and background checks, which restricts many individuals' ability to meet the expectations of the landlord. The LGU SPOA currently has 1,292 individuals waiting for housing, and this does not include individuals in the shelter who are waiting for single or family placement. The LGU SPOA currently has over 40 people in apartment search with agencies who cannot locate apartments. LGU SPOA also have vacancies in our Scattered Site Supportive Housing and licensed programs because agencies have no staff to provide the services if we placed people.

LGU continues to work collaboratively with our Continuum of Care (CoC) Partnership to End Homelessness on permanent housing subsidies for those experiencing homelessness. Over the last year, LGU, along with Coc partners, streamlined housing referral process which has resulted in a 4% decrease in the number of vacancies (from 12% to 8%) and improved overall service delivery. Providers can request new referrals quicker, making it easier and faster to fill vacancies in the CoC system.

LGU, with support of NYS OASAS, added 10 OASAS Licensed Residential Treatment beds this past year. County still has an average of 40 residents in residential treatment outside of Westchester County. This includes adolescents/young adults.

Four (4) funded transitional units to open July, 2025. Still need for permanent housing slots.

Goal 3 Objective 2, 2026 Status Update: Not started

Goal 3 Objective 2, 2026 Status Update Description: At this time County is not actively pursuing goal of establishing a new adolescent co-occurring residential treatment program.

Due to funding uncertainty, lack of sustainable funding and concerns of identifying a provider, site selection County is continuing effort to promote co-occurring treatment and support in existing programs and maximizing current resources.

Goal 3 Objective 3, 2026 Status Update: Ongoing

Goal 3 Objective 3, 2026 Status Update Description: Westchester County, along with other Counties in our region/state, continues to be concerned about NYS OPWDD decision to exclude LGUS's from the Access to Residential Opportunities Committee (AROC). NYS OPWDD does not provide LGU's with any real time, county specific housing data. Without this data and involvement in the housing process, Counties are unable to support the needs of our residents. The County received significant amount of calls on housing issues, challenges, waiting lists from our residents.

Westchester LGU historically managed residential opportunities management with OPWDD DDRO with full transparency to the public, knowledge of vacancies, and collaborative process with DDRO, County, providers and individual/families. The vacancy rates were low and individuals were accessing services.in a timely and consumer friendly approach. Since that ended, there has been no transparency, no collaboration between essential stakeholders and significant concerns from our residents and broader community.

No Need description (Optional): Since the transition from ICM, SCM, Care Coordination and Medicaid Service Coordination (OPWDD), there continues to be significant challenges in providing appropriate level of care and services to adults and children/adolescents with more complex needs. This includes barriers accessing services, lack of responsiveness and intensity of services as well as lack of accountability. Adults with SMI and Children with SED require more immediate access and more intensive level of Care Coordination.

OPWDD Care Coordination continues to be a major failure. Care Managers are poorly trained, lack of accountability, and limited, if any, contact with individuals

No Need description (Optional): To the credit of OMH/OASAS there have been major investments to crisis services for both children and adults. The challenge has been not in allocation of resources but agencies being able to identify/get approval for sites specifically for Children's Crisis Residence and Adult/Children's Crisis Stabilization Center.
