Obtain each agency's protocols for responding to crises - who takes the calls, who responds, what is the response/treatment, and who follows up to crisis calls?

Identify the resources and referral processes for individuals in crisis who are not currently enrolled in any agency; resources might include SPOA, ACT Team, and Youth ACT.

Goal 1, Objective 3, Description Define the staffing and budget needs, and identify an oversight agency or contractor to maintain and monitor a crisis team. Further objectives would be determined by fiscal and agency responsibility as education and cross system collaboration continues to ensure any individual with any treatment need would receive immediate crisis response in the county, regardless of prior agency/service affiliation.

Goal 2: Target Completion Date Jun 30, 2026

Goal 2: Description Cattaraugus County is ranked 61st out of 62 healthy counties (next to last) in New York State. The leading causes of death in the county are cancer, heart disease, and accidents, with a high rate of tobacco use (36.9% of adults smoke cigarettes v. 20.4% average for the rest of the state). Cattaraugus County has only 1 mental health provider / 590 individuals, where the state average is 1 provider / 340 individuals. Recognizing the need for more diverse service options, Department of Community Services is pursuing more integrated clinic options to serve individuals in the county.

Cattaraugus County Dept. of Community Services obtained SAMHSA grant to integrate Substance Use Disorder treatment into the Mental Health Counseling Center in 2023. The Counseling Center hired CASAC and CRPA staff and obtained OASAS license to integrate dual diagnosis treatment modalities in the currently OMH-licensed clinic setting. CASA-Trinity is the only other licensed OASAS program in the county, so this integration offers individuals in the county another provider option. Integrating clinic services also consolidates workforce needs, where peers and professionals can work with dually diagnosed populations in a single clinic setting.

The Counseling Center is applying for additional grants and funding to become a fully integrated clinic to offer physical health treatment, in addition to mental health and substance use disorder services. Objectives toward this Goal will be established in coming months, after grants are awarded.

Goal 3: Description OMH funds provided Cattaraugus County the opportunity to form the Family Voice Advocacy (FVA), overseen by SPOA Coordinator with collaboration from multiple service providers in community, including mental health, substance use, developmental disabilities providers, as well as schools, community supports, peer agency supports, faith-based community, and many other agencies. The goal of the Family Voice Advocacy is to include youth and family/caregivers at meetings to discuss communication needs and ways to close barriers in treatment and service options. The FVA meets monthly to share service information and positive insights about services available in community, breaking down the "us vs. them" mentality while helping to reduce stigma about recovery.

Cattaraugus County Departments of Community Services and Social Services share a Preventative Care Manager position to link homeless individuals in community with appropriate mental health or other services and to provide care management services to children/youth who are not eligible for Health Home Care Management due to insurance or other eligibility barriers.

State Oversight Agencies continue to focus on Peer Service options in communities, and Cattaraugus County seeks to identify the expanded role peers play in helping people to navigate Systems of Care in the county. For example, individuals linked with Health Homes or other Care Coordination services do not receive traditional intensive case management, for which peers might assist in closing gaps in care. Peer Staff from Community Services Counseling Center currently provide peer services at the County Jail, in lieu of professional therapy, to encourage linkages and refer individuals to appropriate service options and assist with discharge planning.

Expansion of Cross Systems in the county would also include transportation or housing linkages, as needed.

As the FVA continues to identify and expand on its mission in the county, they will assist in the expansion of Systems of Care for all individuals, in addition to youth and families.

Title	Establish a Crisis Team					
Update	Cattaraugus County has identified existing crisis supports. Office of Mental Health awarded funds to the county to establish a Crisis Response Team in 2023. The LGU has been meeting regularly with OMH to review the program proposal, budget, and staffing guidelines. The LGU is reviewing staffing needs to create 2 Teams, including a Therapist and a Peer on each Team. Staffing may be one of the most restrictive barriers to setting up the Team, as all mental health agencies in the county continue to struggle with workforce recruitment and retention. County Government oversight of Community Services prevents the provision of recruitment or retention bonuses, which have become a "norm" in other workforce environments. Additionally, Community Services previously recruited new interns and prospective professional candidates from St. Bonaventure University, but the college no longer provides in-person education for its social work program. With a virtual platform, the university students no longer reside in the County and there is no immediate draw for candidates to complete internships. The LGU continues to meet with OMH to discuss other workforce options to get the Team up and running as soon as possible. Once established, the Team will begin to train for cross-systems crisis response (i.e., response to developmental disabilities or addictions crisis). The budget and fiscal planning will also be finalized when workforce standards are firmly established in accordance with updated guidance from OMH.

OMH has not yet announced the grant awards, but FVA hopes to utilize funding to further knowledge of mental wellness and the services available across all systems of care in the county. The FVA also continues to work on a mental wellness toolkit that would be available to individuals. The toolkit would include self-advocacy information, providers linkage information, and general health and wellness linkages for all ages.

Goal 1, 2026 Status Update: Ongoing

Goal 1, 2026 Status Update Description: Since the last LSP submitted Cattaraugus County has finalized plans for the crisis team with the two agencies who will be providing the staff for the team. Since the last LSP we realized we could not successfully put into place the 2 team approach. Upon review of funding and resource we have decided to have a crisis team consisting of one peer and one therapist whose hours would be 9am to 6pm each day with the ability to go into the community if needed. Cattaraugus County will continue to oversee the after hours crisis person who is contacted through the crisis line or another agency in the county to assist with crises from 6pm to 8am each night. Cattaraugus County has spent time in each subcommittee meeting, OASAS, OPWDD and OMH discussing how crisis services would be responsive to their needs as well.. The ideas of cross training has been an important part of these discussions to make sure the crisis team can respond appropriately to all crisis calls.

Goal 1 Objective 1, 2026 Status Update: Ongoing

Goal 1 Objective 1, 2026 Status Update Description: Cattaraugus County continues to use this list as a living document. Many agencies and organizations undergo transitions throughout the year with staffing, regulatory and location changes so depending on these things crisis response could change year to year. During the MH OASAS and OPWDD subcommittee meetings these changes, if any, are reviewed and documented in the meeting minutes.

Goal 1 Objective 2, 2026 Status Update: Ongoing

Goal 1 Objective 2, 2026 Status Update Description: Cattaraugus County continues to attempt to be ready to assist an individual who is presenting in crisis in from any agency. Many of the agencies or providers have worked collaboratively for several years and are part of the collaborative meetings held including OMH, OASAS, and OPWDD providers. We continue to navigate regulatory barriers in all of the state agencies..

Goal 1 Objective 3, 2026 Status Update: Complete

Goal 1 Objective 3, 2026 Status Update Description: Cattaraugus County has identified two local agencies to staff the crisis peer and crisis therapist. We are awaiting the final signature on these contracts. Once in place the crisis team will be in place and functional. Initially training will be done to ensure the crisis workers are aware of county and department policies. Notices to county agencies, OASAS OMH and OPWDD about the crisis team will be provided to inform of protocols for the crisis team and the after hours crisis response.

Goal 2, 2026 Status Update: Ongoing

Goal 2, 2026 Status Update Description: Cattaraugus County continues to fare worse than the average county in NYS for community conditions and slightly worse that the average county in the nation. This is documented in the county Health rankings and has been a driving factor in applying for an integrated license. This application was completed and we are awaiting a response or any additional information needed. Cattaraugus County feels that the integrated clinic is more than just behavioral and physical health. Cattaraugus County has collaborated with the OPWDD agency in a drop in center and a pharmacy ,these are expected to begin functioning later in 2025.

We continue to provide Substance Abuse assessment outpatient treatment and MAT services. We provide oral naltrexone, vivitrol and the sublocade injections but due to the lack of staff to monitor the medication side effects each day we have had to turn away referrals, the new data indicates the ability to provide the medication and monitoring in a much shorter time. We have a MAT through our contracted psychiatric provider and are hoping to begin accepting sublocade referrals in the next few months.

Goal 3, 2026 Status Update: Ongoing

Goal 3, 2026 Status Update Description: Cattaraugus County continues to follow the goal of collaboration among county agencies and departments that was enhanced through the awarding of funding through the Systems of Care Grant.. The county has a rich history of collaboration and attempting to overcome regulatory and roles barriers in order to provide services to our county. We oversee the High Utilizers of Services meeting that includes law enforcement, the local hospital, care coordination agencies, the public defender, treatment court, substance abuse agency as just an example of the collaboration in the county. The Mental Health tool kit continues to be updated and added to when new information or links are provided.

The LGU opioid settlement funds made available have also been used for collaboration with agencies and county departments who are being impacted by opioid use/ addiction. The county departments MOU's are in place and resolutions for contracts are being prepared for our contract agencies.

In May of this year the Family Voice Advocacy committee presented an Art Show with the theme of "What is recovery?" It consisted of art projects from children ages 5-18 in our county with the art work showing the child's definition of recovery. The committee was able to judge and award prizes and the Art Show was announced in local papers.

Cattaraugus County continues to use peer services to bridge gaps between clinical and care coordination services. We have had peer positions open at times through the year. We continue to use the peer service as much as possible. We realize that in the the Jail relationship building is very important and increases the chance of needed follow-up occurring is increased significantly. The peers in the PROS program and the clinic have been great additions to the programming and have become an integral part of our locations.

The introduction of the 1115 waiver has expanded the level of services that the county can offer. One of our OPWDD agencies is close to opening a drop in location close to the county center that will have a variety of information about programs and information about Cattaraugus County resources.
