**Goal 1:** We will continue to strengthen the crisis continuum through the implementation of crisis respite beds, a crisis stabilization center and a local, North Country, 988 call center.

**Goal 2:** Through system of care, we will serve complex children and families, identify barriers to access and appropriate services, and increase education in trauma, resiliency and prevention in schools and community.

**Goal 3:** We will expand our partnership with Law Enforcement and Behavioral Health Providers with CIT training. We will continue our work of communication and collaboration to divert vulnerable populations from the justice system with LEMHRS, Imminent Risk Meetings and educational opportunities.

# Annual and intermediate plans for <u>addiction</u> services:

- -Supporting the development of our local OASAS provider's building and utilization of the Crisis Stabilization Center.
- -Tracking and gathering data for LEMHRS regarding overdose reports with HIDTA and improving outreach and engagement
- -Developing and implementing services at the local jail with MAT services and treatment programming for the

incarcerated SUD population

- -Implementing the STAR program with the hospital for emergency room bridge prescriptions and outpatient
- appointments for the SUD population
- -Improve and expand imminent risk committee to identify individuals that pose a safety concern and to educate/support partners

- -Serving complex families and developing/creating/providing appropriate supports with children in the OPWDD system

Need description (Optional): Education of Adverse Childhood Experiences and Evidence Based Practices that buffer trauma and improve resiliency need to be implemented or reinforced throughout the community. A significant amount of community education, collaboration and practices were prioritized in schools in 2017 and 2018 and it seems as though post pandemic much of the work has been lost or set aside. This work needs to be supported to strengthen the school system and to educate the community on the impact of trauma on children. We need to address the societal trauma of the pandemic, to heal and improve the overall wellness of the community.

Need description (Optional): Workforce needs, vacancies and turnover, negatively impacts the ability to provide enough staff to adequately provide case management and care coordination.

Need description (Optional): The risk and acuity of the SMI and SED population is greater than it has ever been. The emergency rooms are

overwhelmed and the workforce is suffering. Strengthening our crisis continuum is vital to support the community and to

prevent further escalation of those in crisis. More individuals are in crisis with fewer resources due to staffing, availability of appropriate interventions or barriers that exist with regulatory agencies.

Our community has unique characteristics that do not fit in many current crisis models. There are geographical

considerations in terms of travel and response, hazardous driving conditions with snow and/or ice, and often service

deserts in terms of access to phone service or internet service. We need innovative, flexible and unique solutions.

Need description (Optional): Barriers to true person–centered, individualized work, is due in part to regulations that prevent blended services. These barriers provide the community with little funding flexibility to support individuals who are in multiple systems or have complex needs. Individuals and families should not have to choose the services system or prioritize a need because the systems are not built to accommodate.

Disparities in access to services exist with insurance coverage and are a health equity issue.

Need description (Optional): There are not enough flexible or accommodating employment or volunteer opportunities for individuals in recovery seeking employment. The community needs more education and support for employers to provide diverse employment experiences and opportunities. Stigma is a contributing factor that narrow opportunities. Employers often take an all or

nothing approach to employment/volunteer opportunities and positions need to be reimagined to be more accommodating.
