# **Essex County Mental Health Services**

**Goal 1:** Increase availability of supportive/therapeutic housing for County residents (a) with Serious Mental Illness (SMI), (b) with substance use disorders, (c) at-risk youth, and/or (d) people with Intellectual/Developmental Disability (I/DD)

**Goal 2:** Establish crisis stabilization/respite services for youth and adult for youth and adults (a) with Serious Mental Illness (SMI), (b) with substance use disorders, (c) at-risk youth, and /or (d) people with I/DD

**Goal 3:** Identify and quantify the breadth and depth of the shortages ad/ore vacancies within provider agenices.

**Goal 4 (Optional):** Increase integration of care through a System of Care by leveraging Essex County providers' capacities involving human services, education, health and the justice system.

# Annual and intermediate plans for addiction services:

In Essex County, our focus is to utilize referrals coming through the LEMHRS (Law Enforcement Mental Health Referral System) as a way to encourage those with SUD to engage in services. Typically, the people who are coming to us through that system are the more "ill" community members, than those coming from other resources.

# Annual and intermediate plans for <u>developmental disability</u> services:

Improving prevention services for children at the highest level of need is our focus. We want NO child sitting in the ER with no place to go for higher level needs of service.

Additionally, we want to figure out how to restore our children's respite services for beyond that of <24 hours. We had a wonderful respite system in place years ago and we would like to figure out a way to restore that system.

# Annual and intermediate plans for mental health services:

Our biggest need for mental health services is meeting the need of school-based services. This is a workforce issue. In Essex County, the closest Social Worker of Mental Health Counselor colleges are 1.0 to 1.5 hours away. Unless someone lived her prior to college and has plans to return to Essex County to provide schools, we have a very difficult time recruiting staff. Additionally, the available moderate-income housing in Essex County got swallowed up by persons coming from other regions to live in and work remotely in the Adirondacks. We are in a housing crisis.
