Goal 2: Title System of Care: To partner with community and/or county-departments/agencies to develop a System of Care for children/youth and their families for prevention and treatment.

Goal 2: Target Completion Date Jan 01, 2025

Goal 2: Description To develop a better integrated behavioral health system of care for children and youth given the high need for, and significant gaps in the mental health continuum of care especially in the aftermath of the pandemic. The development of a System of Care (SOC) for children/youth would essentially allow all systems that care for our children/youth and families to work together and pool resources (including financial ones) to provide opportunities for children/youth to be linked to appropriate resources/services regardless of which system they enter first (i.e., OMH, OCFS, DOH, etc.). The goal of the SOC is to offer opportunities for prevention/treatment to minimize the development or worsening of mental health and/or substance abuse problems, suicide or opioid overdose, out of home placement/psychiatric hospitalization, and/or the over-utilization of emergency rooms, as well as offer opportunities for intervening sooner with families toward resiliency skill-building to children/youth and families to create a healthier, safer community.

Goal 2, Objective 1, Description The Departments of Mental Health, Social Services, Public Health, and Finance will setup meetings to begin discussions about immediate solutions/plans for the expansion of services for children/youth as development of the SOC will take time given that it involves a multisystem approach.

Goal 2, Objective 2: Title Expansion of contracts with Department of Social Services to access prevention/treatment services through OCFS/Family First.

Goal 2, Objective 2, Target Completion Date Jan 01, 2024

Goal 2, Objective 2, Description Work with Department of Social Services (DSS) to expand current MOUs and contracts with Cayuga Centers (a nonprofit organization serving children and families) for all levels of evidence-based, home/community-based services, using Opioid funds to offset the costs of this expansion where DSS is not able to get reimbursement for the County. This will immediately offer additional services/programs to children/youth and families through SPOA while the SOC is in development, and while we work to create processes to maintain the SOC in an ongoing way.

Update	The LGU signed letters of support to expand supported/supportive housing within the community for individuals living with mental health or co-occurring disorders. Lakeview Health Services, Inc. applied for two supported housing grants and received one of these grants and the other is pending. DePaul also applied for a grant to expand existing short-term transitional housing with LGU support, which is still pending. The LGU will continue to sign letters of support for expansion of housing programs across all three State agencies.

Update	The LGU is in the process of developing a System of Care for children/youth through partnerships with other county departments as well as community partners. Specifically, the LGU entered into a contract with the local DSS office to give access to Multisystemic Therapy and Functional Family Therapy to children/youth and families to increase support or the intensity of treatment/support services. The LGU is working with Children's Home Wyoming Conference (new provider to Ontario) to expand CFTSS/Medicaid services for children/youth. They will work to license their CFTSS office that has moved to Geneva, which is in Ontario County.

Update	Ontario County Mental Health (MHTORS/Article 31 County Clinic) graduated from the OUD OMH Initiative and currently offers all 5 best practices and we have successfully inducted several individuals and are maintaining several others. We offer the full array of MAT, Narcan, oral Suboxone, vivitrol injections, and are working on offering Sublocade injections in 2025. Minimal progress on Harm Reductions efforts so will continue to explore initiatives to expand knowledge of HR in the community. For instance, working on better messaging via online resources (CredibleMind) to get the word out about HR and other mental health resources.

Goal 1

Goal 1, 2026 Status Update: Ongoing

Goal 1, 2026 Status Update Description: • Submitted letters of support such as to DePaul, Lakeview, and FLACRA

- Lakeview & DePaul awarded RFPs, which will bring new transitional/ supported housing units
- Transitional Housing Unit dollars from OASAS
- Attendance at OC Housing Committees
- Ontario is developing homeless shelter via charitable donations and contracts through Ontario Housing Committee

Goal 2

Goal 2, 2026 Status Update: Ongoing

Goal 2, 2026 Status Update Description: -Developed a new Mental Health Services Coordinator position (1/1/25) to bring the system of care project forward. This took 1-year to secure as the Board of Supervisors and Workforce shortages caused delays.

-Expansion of Multisystemic Therapy and Functional Family Therapy in collaboration with Department of Social Services and Cayuga Centers to offer community and home-based services via child SPOA or preventative services referrals.

Goal 2 Objective 1, 2026 Status Update: Ongoing

Goal 2 Objective 1, 2026 Status Update Description: The system of care initiative was delayed due to workforce shortages, staff turnover, and changes in county stakeholders who were to be part of developing the system of care. Also, a major CFTSS provider for the region (Cayuga Centers) will no longer be providing these services to the Ontario County community due to sustainability and workforce issues.

Goal 2 Objective 2, 2026 Status Update: Not started

Goal 2 Objective 2, 2026 Status Update Description: Child respite opportunities are minimal in the community due to workforce challenges and lack of respite programs in the area. There was a potential opportunity through Cayuga Centers that did not pan out due to limited resources available.

Will continue to explore other options for respite. One idea is to attempt to RFP for new community agencies or non-licensed programs to provide respite opportunities if available.

Goal 3, 2026 Status Update: Ongoing

Goal 3, 2026 Status Update Description:

2 MAT providers; and MAT provider available 50% of total clinic time!

Staff training (2 Parts) on Motivational Interviewing by CCSI; and staff trainings on integrated care approach and treating SUDs!

Narcan, Fentanyl, and Xylazine test strips, with education included, offered to all clients of the clinic

IM for Vivitrol and Sublocade available!

Jail MAT - full array of services offered now (Sublocade)

CredibleMind rolled-out, with resources for SUD/OD/MAT

Need more focused on Harm reduction and prevention

OC Jail provides a full array of MAT between FTE (NPP MAT provider) and contracts with FLACRA!

Goal 3 Objective 1, 2026 Status Update: Complete

Goal 3 Objective 1, 2026 Status Update Description: The County's MHTORS clinic has fully implemented all 5 MAT best practices and graduated from the OMH OUD program, and the clinic offers the full array of services to clients. We also have two contracted psychiatric providers who provide MAT (telehealth or in-person) including maintenance or induction of medications for MAT as needed.

Goal 3 Objective 2, 2026 Status Update: Ongoing

Goal 3 Objective 2, 2026 Status Update Description: -Staff training (2 Parts) on Motivational Interviewing by CCSI; and staff trainings on integrated care approach and treating SUD/OD including harm reduction interventions and strategies.

-Narcan, Fentanyl, and Xylazine test strips, with education included, offered to all clients of the clinic; these items are also available via FLACRA and Ontario County Public Health, as well as in certain designated spots in the community.

-CredibleMind contract and website resource was rolled-out, with resources for SUD/ODU/MAT and about harm reduction strategies.

Goal 4

Goal 4, 2026 Status Update: Ongoing

Goal 4, 2026 Status Update Description: Signed agreements with colleges including St John Fisher, Roberts Wesleyan, and Keuka College for social worker/mental health counseling interns. Also, signed agreements/contract with RIT for psychology pre-doctoral interns and fellows. MHOTRS program is fully staffed with primary therapists and service coordinators. Working to still fill primary therapist, clinical supervisor, medical billing, and clinic-based peer positions. Fully staffed with Community Mental Health Professionals due to advocacy with County HR and County Executive to re-negotiate CSEA contracts (better salaries); and advocated with county administration/HR for a "salary study" of all positions and this helped to increase salaries for most titles across the county. Advocacy with HR to update re-title positions and expand the pool of candidates; creation of new positions to oversee new programs/services; and advocacy for certain titles including CMHP to be included on HELP program with civil service to waive test that may be a barrier to some for employment.

Goal 4 Objective 1, 2026 Status Update: Ongoing

Goal 4 Objective 1, 2026 Status Update Description: Established a pre-doctoral internship via signed contract/agreements with RIT's Psychology Consortium and gained two 2 psychology interns. One intern will stay as a post-doctoral psychology fellow next year and will assist with expansion of consultation/supervision or staff/interns/CBNs, and will help us with expansion of court-ordered/other psychological evaluation services.

Goal 4 Objective 2, 2026 Status Update: Complete

Goal 4 Objective 2, 2026 Status Update Description: Approved as a HRSA site (loan repayment program) to attract candidates and keep staff. Have received some applications thus far, but no one has been hired or offered an interview from the HRSA site.

experienced record high numbers of homelessness in Ontario County compared to past years including families with parents and children.

This need is especially severe for children/youth with youth spending days in the ED/CPEP waiting for an inpatient bed only to be declined due to lack of availability and eventually discharged to home despite continued concerns from families and providers.

There is child respite at EPC, which is about 1-1.5 hrs away for families in our County and can be a barrier to utilization of this program. DSS and Probation Departments have few respite options at this time; and OMH has 1 respite bed option in its adult SOCR in Geneva and through the Community Residence program at Lake Breeze/Pathways Inc for children/youth. The transitional housing program (3 beds) through Lakeview Health Services has been unoperational since the start of the pandemic due to staffing issues.

Need description (Optional): The LGU continues to see an increase in the number of CPL 730 referrals from Ontario County courts; however, there continues to be a lack of licensed psychologists or physicians who are interested or able to provide forensic/court ordered evaluations. There continues to be a high need for 730 Diversion programs such as Crisis Intervention Team, Mobile Access Program, Assisted Outpatient Treatment, Specialty Treatment Courts such as Mental Health Court, and other levels of crisis intervention to divert persons with disabilities from the criminal justice system. The LGU in conjunction with the County Executive and other County stakeholders have developed a CPL 730 Work Group to discuss diversion options such as education for attorneys or court, alternatives to incarceration such as offering outpatient mental health/substance abuse resources, etc.

For children/youth, the closest respite bed is in Chemung County that is inaccessible to many families due to transportation barriers; and one bed in a community residence (CR) program through Pathways, Inc./Lake Breeze Community Residence within the County that is used on a limited basis due to staffing gaps at the CR facility. For adults, Lakeview Health Services, Inc. operates the only licensed respite program for adults (i.e., Prospect House).
