Goal 1: Description Orleans County has identified both a short term and long-term need for safe and adequate housing options for those who have disabilities, including mental health needs, substance use needs, and developmental disabilities. The Orleans County homelessness data has demonstrated an overall increase of 174 % increase in the past two years, which has resulted in individuals being re-located outside of the county to neighboring counties, which results in loss of treatment services and supports, as well as difficulties surrounding efforts to engage them in treatment and supports.

Goal 1	
Title	Orleans County desires to meet housing needs for its community members with disabilities.
Update	During the 2024 year, Living Opportunities of DePaul with support of the Orleans County LGU applied for and was awarded an additional 10 supportive housing beds in Orleans County. In addition, Orleans County Mental Health Department in collaboration with Living Opportunities of DePaul will contract for an additional two crisis-short term beds, which will increase crisis / emergency housing beds in Orleans County from 5 to 7 beds. Both the crisis and supportive housing bed additions are in process of locating apartments / infrastructure in Orleans County to secure these beds. UConnect Care, and OASAS provider in Orleans County is set to open a 25 bed women's residential housing program in Orleans County in September 2025. Respite services and support for both adults and youth continue to be a need in Orleans County which requires additional advocacy, funding, and support.

Title	Community Based Services
Update	Orleans County continues to offer two mobile crisis response teams serving the Orleans County community. The Rochester Psychiatric Center MIT Team operates Monday - Friday during business hours and serves adults only. The CARES Team (Spectrum Health & Human Services) (contracted provider) continues to operate evenings, weekends, and holidays. We are closely monitoring utilization of these mobile crisis team programs and exploring ways to promote these resource throughout the community including with community providers, medical / physical health providers, EMS, and Law Enforcement. In collaboration with Genesee / Orleans Public Health Department, in 2024 the Leave Behind kit prevention program was launched in Orleans County. This program provides first responders, mobile crisis teams, and the local DSS and Probation Department staff with kits to be left in households for those households who may be at high risk for SUD use or suicide. UConnect Care (OASAS) programming serving Orleans County opened their OTP program in Orleans County in 2024. The Orleans County Director of Community Services has joined the Genesee & Orleans County Public Health Departments Early Intervention stakeholder committee.

Title	Suicide Prevention / Postvention
Update	In 2024 in collaboration with Genesee County Mental Health and the Genesee / Orleans Health Department, the Genesee / Orleans Counties Fatality Review Board was started, Next of Kin Interviews are being conducted as part of this Fatality Review Board. The Orleans County Suicide Prevention Coalition continues county wide and regional wide efforts to promote suicide awareness, postvention planning and projects, and to promote the education of available mental health supports in resources in Orleans County. The Orleans County Mental Health Department is

	exploring ways to include the department resources and community based resources in localized events, including a Mental Health Awareness walk, Overdose Awareness Day in August 2024, National Night Out (August 2024) and additional programs / opportunities. There is discussion of implementing an anti-stigma campaign in Orleans County.

2026 Update to 2024-2027 Goals and Objectives Orleans County Department of Mental Health

Goal 1

Goal 1, 2026 Status Update: Ongoing

Goal 1, 2026 Status Update Description: Living Opportunities of DePaul has secured the additional 10 supportive apartment program beds for Orleans County. Living Opportunities of DePaul continues to make an effort to locate infrastructure to support these beds throughout Orleans County, but they have been awarded and secured by way of contract between the provider and New York State OMH (funding source). The two additional crisis apartments for Orleans County as overseen and directed by Living Opportunities of DePaul are up and operational. This has been a huge asset for the county, and there continues to be a wait list for emergency/crisis apartments, even with the two additional beds online. UConnect Cares Women's & Children's 25 bed residential program has an anticipated opening date of September 2025. We look forward to this on behalf of the county, community and region at large to be a resource for mother and their children in recovery. Respite services for both adults and youth continue to be an identified need in the county, and there has been minimal to no progress on addressing this.

Goal 1 Objective 1, 2026 Status Update: Ongoing

Goal 1 Objective 1, 2026 Status Update Description: Living Opportunities of DePaul has secured two additional short-term crisis / emergency apartments, which now totals 7 emergency/crisis beds in Orleans County. Even with the two additional beds, there continues to be an active waitlist for the crisis/emergency apartments in the county. In collaboration with Department of Social Services, the need for housing continues to be an issue in the county, and there lacks infrastructure to secure appropriate housing for the community or for providers who work through housing programs (i.e. DePaul, Pathstone, DSS). Residents are having to be placed in out of county assets to meet their housing needs, which results in a significant cost to the county as well as barrier for the residents to maintain natural and program supports.

Goal 1 Objective 2, 2026 Status Update: Ongoing

Goal 1 Objective 2, 2026 Status Update Description: The UConnect Care (formerly GCASA) 25 bed Women's and Children's facility anticipates opening and accepting referrals in Q3 of 2025. At this time UConnect Care has secured state aid start up funding and is finalizing logistics for operations i.e. staffing, furniture.

Goal 1 Objective 3, 2026 Status Update Description: Respite for both youth and adults continue to be an active need in Orleans County.

Goal 2, 2026 Status Update: Ongoing

Goal 2, 2026 Status Update Description: Orleans County is currently working with crisis providers (Care & Crisis Helpline, Mobile Crisis Teams, and Department run Crisis Staffed program) to re-imagine the crisis intervention program to uphold and maximize utilization of the crisis programs, while making an effort to sustain all resources (types of crisis response). At this time reimbursement for crisis services is minimal to none, which creates a barrier for providers. Also workforce for crisis response programs is a barrier, given the type of work as well as the geographical footprint of the region / county it is serving.

Goal 2 Objective 1, 2026 Status Update: Complete

Goal 2 Objective 1, 2026 Status Update Description: The OTP clinic is open and operational in Orleans County, through UConnect Care. They are actively a resource to the county and have availability for referrals at this time.

Goal 2 Objective 2, 2026 Status Update: Ongoing

Goal 2 Objective 2, 2026 Status Update Description: We are continuing to assess, and re-imagine the crisis response plan in Orleans County, in an effort to sustain all program types, but with improved access, improved appropriate utilization, and sustainability of financial infrastructure for all related programs. We are considering adopting and implementing a 911 Diversion/Dispatch training to provide additional training to Dispatch for triage to most appropriate crisis response program. We have made increased marketing/promotional efforts of the Care & Crisis Helpline (local helpline) and 988 through weekly newspaper advertisement (online and hard copy), promotional materials at events, and other avenues to divert calls from 911 to 988 or the local crisis helpline. Call volume to the local Crisis Helpline is increasing.

Goal 2 Objective 3, 2026 Status Update: Ongoing

Goal 2 Objective 3, 2026 Status Update Description: We are increasing marketing materials/promotional/educational materials in our community through various avenues to promote the available Mental Health Crisis Resources in Orleans County. This includes participating at events - where materials are provided to attendees, advertisements (Weekly) on the Orleans Hub and Daily News (local newspapers), t-shirts (walking billboards).

Goal 2 Objective 4, 2026 Status Update: Not started

Goal 2 Objective 4, 2026 Status Update Description: This continues to be an identified goal/need in Orleans County. We are hearing this as concern through various providers (Pediatricians, Schools, Public Health) that this goal and need should continue to be priority for Orleans County. Limited providers in the area is a barrier, as well as the need for providers to have experience and comfort with working with young children.

Goal 3

Goal 3, 2026 Status Update: Ongoing

Goal 3, 2026 Status Update Description: The Fatality Review Board was started and continues in operation. In Orleans County three NOK interviews have been conducted, with one Fatality Review Board meeting having taken place to date. Additional project in relation to this goal that is in process for Orleans County in year 2025 is the NORC Research Project / Listening Tours / Surveys that is a community wide initiative addressing stigma associated to substance use, overdose, mental health, and suicide. Listening tours / sessions and surveys have been conducted, and a final report of findings will be released to the Orleans County LGU/DCS in August 2025. The Orleans County Suicide Prevention Coalition continues ongoing promotional and educational efforts throughout Orleans County in 2024.

Goal 3 Objective 1, 2026 Status Update: Ongoing

Goal 3 Objective 1, 2026 Status Update Description: A regional suicide prevention coalition is taking shape, GOW Pathway to Hope. Orleans County still has its own Suicide Prevention Coalition and is hosting their own meetings and own events and efforts, but is actively involved and collaborating with the Genesee and Wyoming Counties as part of the GOW Pathway to Hope initiative.

Goal 3 Objective 2, 2026 Status Update: Ongoing

Goal 3 Objective 2, 2026 Status Update Description: Ongoing limited progress / efforts to report in relation to this goal in 2025. Postvention kits are still available in Orleans County to provide to family members / friends who have lost a loved one to suicide. We are looking forward to making additional efforts related to goal/objective in the upcoming year working closely with Public Health Offices, Law Enforcement Agencies, Clergy / Funeral Home Directors, and regional partners.

Goal 3 Objective 3, 2026 Status Update: Ongoing

Goal 3 Objective 3, 2026 Status Update Description: The Suicide Prevention Coalition continues to actively participate and be represented at community events to promote 988, SafeTalk, and Talk Saves Lives. The coalition is working with their counterparts in surrounding counties to reinforce and promote these efforts in the region.
