Goal 1: Title Safe Affordable Housing

Goal 1: Target Completion Date Dec 31, 2025

Goal 1: Description Schuyler County continues to see a reduction of safe affordable housing stock, which has now been occurring for over 5 years, resulting in many lower income, at risk persons not being able to live in the area they prefer to. This is a much more difficult problem to address as investors continue to buy the multiple unit apartments that were once available and instead of continuing to use them for long term tenants the houses are turned into Air B-N-B's and other short term rental set ups. Schuyler County has a housing committee that is working with investors, landlords and local housing agencies to try and buy, fix up or plan new options for housing. Catholic Charities and Arbor Development have been involved for many years, but without start up funds or new large grant options, housing is becoming increasingly difficult for many people to find within Schuyler County. The availability of new grant money for safe affordable housing, provided through a local housing agency, would greatly benefit Schuyler County residents.

Goal 2: Description 730 exams have historically not been used very often in Schuyler County. Last year we had an increase and 2023 is going to exceed last years number. As a small county we have minimal resources for a very specific law, and we need help in the following areas: 1) Access to a 'pool' of Psychiatrists that we can contract with to provide a 730. 2) pursue a change in the law to allow different disciplines to complete the assessments. NPs fulfill many of the same responsibilities as an MD but are not allowed to do a 730. LCSW's, according to NYS, are comparable to a PhD Psychologist but are not allowed to do a 730. Having access to these disciplines to provide the 730 assessments would be welcomed. Restoration, and the county expense, has been astronomical and it must be a priority to make some changes in how this expense is pushed back to a county.

Goal 3: Description Schuyler County Community Services, and the Mental Health Clinic in particular, has seen a drastic decrease in professional staffing applications which has resulted in almost half of clinical positions being vacant in recent months. There are a variety of reason that have been discussed as Licensed Clinicians have moved on to other positions. These reasons are worth noting to attempt to adjust for new staff, as recruitment and retention must evolve as the larger workforce evolves. Remote work, pay rate and tuition reimbursement are the three main strategies that have been cited by staff as they have left. Schuyler County is looking at each topic and adjusting where possible. The rate of pay and the tuition reimbursement for Licensed Clinicians are being discussed with union and civil service representatives, though additional State Aid specific to each would strengthen the argument to the County and possibly result in retaining staff. Staffing flexibility, days worked, and part-time status are all being considered as the County looks to different ways to advertise the staff openings.

Goal 1, 2026 Status Update Description: Housing continues to be an area of need for Schuyler County. Schuyler County has partnered with Urban Partners for a housing study. To date, there has been a survey conducted, and a Comprehensive Housing Study and Needs Assessment. This report is an in-depth analysis of the existing housing supply and market conditions which will provide a baseline for future housing needs and strategies. Needs and strategies will be identified in the next phase of the study and included in the final report to be released in early fall.

There is a lack of available psychiatrists locally to perform these evaluations. Schuyler County is in the process of contracting with a telehealth provider that specializes in Forensic Evaluations as an attempt to alleviate this barrier.

Goal 2 Objective 2, 2026 Status Update Description: County DCS researched laws and regulations related to the 730 process, which requires a Psychiatrist or Psychologist. The county is in the process of contracting with a local Psychologist as well as a telehealth provider group specializing in Forensic Evaluations.

Schuyler County Mental Health continues to participate as an approved HRSA Loan Repayment site to attract additional candidates. We have also applied for the Round 5 OMH Community Mental Health Loan Repayment Program for two clinicians, which is a potential incentive for staff retention.

Schuyler County Community Services invested in trainings for County employees in 2025. The trainings "Workplace Interpersonal & Customer-Focused Competencies" and "Emotional Intelligence" were provided for interested County employees.

We continue to promote a healthy work environment through promoting training opportunities and offering remote work opportunities where appropriate.
